Landfill Board's Choice For Proposed High School

The Board of Education last evening released schematic drawings prepared by Architect Thomas A. Vail for a new high school that could be built on the landfill at an estimated, total cost of \$1,821,000. Accommodating 500 to 600 students in grades 7-12, the building would consist of 29 classrooms, a library, supervised lunchroom, 600-seat auditorium, 1000 seat gymnasium as well as administrative offices and parking facilities for 200

Closely following the recommendations made by a Citizens Advisory Committee on School Expansion in 1966, the plans for the proposed school must receive final approval from the Mayor and Council at their business meeting on Monday evening.

Frederic President Reese, acting as spokesman for the board, said that their report and architect's drawings were the result of a long study on needed school expansion that also included the possibility of bussing students out of the South Amboy district on a tuition basis and building on the present City Hall site. These were rejected as being both too costly and inadequate for quality education programs of the public school student.

Increased Enrollment

Since 1958 there has been a 35% increase in enrollment in the public schools, and current figures show 594 pupils in the elementary school, 434 in the high school and 21 educable students who are bussed to other districts. A projected enrollment for the next 10 years shows a 31% increase bringing an expected total of over 1300 students. Supt. Eugene Dobrzynski reported that registration for the coming year already includes 111 children for the kindergarten with an additional 15% not yet registered. In the high school, grades 7-12, there will be 485 students, 51 more than now enrolled in these classes.

Costs Compared

Projected costs on bussing 9th through 12th graders into another district. for the coming year, provided a neighboring community would be willing or was able to accomodate these students, show that they would be higher than the approved budget for 1968-69. Sending students into another district would involve tuition of \$700. per student, transportation at \$20,000. rental fee of \$30,000. for a total of \$260,000. (The rental fee is a fixed charge common with receiving districts that allows a five percent rental based on the original cost of the building

and subsequent additions.) Added to this cost would be \$350,000. for the kindergarten through 8th grade budget for a total of \$610,000. The approved budget for 1968-69 is \$519,000. which provides for a continuation of the present school situation --split sessions in grades 1-6 and overcrowding in the high school, built in 1918 to accommodate 250 students.

The proposed school for the landfill would utilize 82,000 square feet as compared to 66,000 square ft. that could be built on the present City Hall site. While this latter site has been favored by council members in the past, the board rejected its use as being completely inadequate for current needs or for future expansion. While estimated costs for this site would be \$1,400,000., it would be necessary to build a 3-story building that would run into the sidewalks on George, Stevens, and John Sts. It would also, according to the board, lack needed faci-

Many Factors Considered

The present public school facilities consist of two joined buildings facing John St. with the high school having 12 classrooms, a science laboratory, manual arts shop, home economics shop, art room, library, and 2 substandard classrooms in the auditorium, where a movable partition that does not soundproof the rooms has been installed. The elementary achool consists of 13 rooms used by 22 classes, forced into split sessions for the past 2 years.

In seeking to alleviate the over-crowding, the board has, in the past few months, investigated the feasibility of putting some elementary school students into classrooms in the Presbyterian Church School and Christ Church Memorial Hall, Both sites were inspected by County Supt. Robert Blunt who insisted that improvements had to be made in lighting and safety features before those classrooms could be considered for approval. The costs for these improvements would be undertaken by the owners but it was felt that they would be reflected in the rental fees to the board. Other factors considered for a new building rather than using improvised temporary class space was the reaction of parents as indicated in recent letters to the CITIZEN. The letters showed concern not only about children being separated from the main school building but about

costs as well. The theme of most letters was that quality education was deteriorating in South Amboy and there was concern of how long Hoffman High





Andy was referring to John J. Connors, father of our present Second Ward Councilman, John F. Connors.



JOHN CONNORS, SR.

John J. Connors, Jr. was born in South Amboy on June 10, 1891 and lived here all his life. He attended St. Mary's High School, where he became an outstanding football player. He was also interested in other sports, but football seemed to be

when he entered the world of politics, Connors claimed that it was so exciting it would make one of the old Sheridan football games look like a ladies pink tea party. John Jr. played as right-halfback on that famous Bergen Hill

When he left school, Connors entered the employ of the Penn Railroad and eventually became Clerk of the Yardmaster's office. When World War I broke out, he was in the first five percent that left for Fort Dix in September, 1917. Here in Camp Dix, Connors, along with others, helped organize Company H of the 31 Ith. Infantry in the 78th. Division, later fames as New Jersey's "Lightning"

Division".
(Dave Kelly is a Brigadier General in the 78th. See column of April 11.)

Entering the service as a private, Connors soon rose to the rank of First Sergeant, and from all reports, he was both efficient and popular, a distinction that few first sergeants ever achievel When he was discharged from the Army, he received a recommendation for a commission in the Officer's Reserve Corps, and became a Second Lieutenant.

Connors saw active service overseas from May, 1918 to the signing of the Armistice. While overseas, he was gassed in action, and was attended by Captain John Francis Weber, South Amboy's esteemed physician.

Connors was always interested in politics and when he ran for Councilman

of the Third Ward, he was given a splendid majority. When he took his seat on January 1, 1923 he was made chairman of the Police Committee, Fire Committee, and Poor Committee, as well as being recognized with appointments to other important committees.

John Connors, Sr., the father of John, Jr. (obviously) and the grandfather of our councilman, John F., was born in Ireland, November 21, 1862, and came to this country when he was sixteen years of age.

Settling in South Amboy,

he worked in the section gang for about one year under the supervision of Thomas Bowe. He then became a trimmer at the local coal docks, a position he held for twenty-five long years. He was considered a conscientious worker and the shipper, R. F. Cahill, leaned heavily on Connors, knowing that he could well trust him in the carrying out of the work at the piers. When South Amboy was still a borough, Mr. Connors was made borough marshall for two years,

1905 and 1906. He also became a director of the Star Building and Loan Association during this period.

Connors joined the fire department in 1891, and after serving in the various offices of this organization, he was elected to the position of chief, in 1907. It was in this capacity that he became affectionally known as "Chief".

Sometime around 1914, he was made Street Commissioner of the City of South Amboy and from all accounts of his terms of office, the city was fortunate in having a man of his calibre filling this important position.

John, Sr. married the former Catherine Mc-Gonigle and the couple had seven children; Mary, Margaret, Catherine, Julia, Stephen, Edward and John, Jr. Of the above, only Julia is living, her father died in the late '40's and her mother around 1944


