#### COUNCIL ANSWERS QUERIES ON LAND-FILL

Former Mayor John Leonard brought out in the open a question that has been formenting around town for many weeks. "Where does South Amboy stand on the aluminum plant? Is a high county official, Freeholder George Otlowski, going to be allowed to critize our biggest taxpayer, Jersey Central Power and Light Company and no one answer him? Leonard wanted to know.

The council and mayor responded as follows:-

Council Pres. Henry: -"We heard about this business in December because Jersey Central heard about the possibility of using the land-fill area for a possibility of getting a big industry in there. We have made no committments with anyone. We want to do what is best for South Amboy. Councilman Howley: -"We were asked whether or not we were interested in attracting industry to the land-fill. We said yes. There was absolutely no mention of an aluminum plant per se. I will never go for anything that is detrimental to South Amboy. I am against contamination." Councilman Connors: -

"We have a very valuable piece of property here. It is known throughout the industrial world. I will never go for anything that is harmful for South Amboy. I intend to live here the rest of my life."

Councilman Rush: -"There will be a public hearing. All the facts will be presented. We will not go for anything that is detrimental to the city."

Councilman Zebro: -"We will do what we thing is best for the town.

Mayor Schultz: - "I repeat what I said at the Sayreville meeting, have made no commitments with anyone."





Joi any Hossiel Does this name ring a bell, or, more appropriately, a gong? Johnny Hossie, as you may remember him, or, John Hospidor, as I know him, was born and raised in Perth Amboy and was very active in the boxing arena during the period of 1924-29. John is now employed by the Middlesex County Parks Department as a radio dispatcher for the police department, and still resides in Perth Amboy.

During his career as a boxer Hossie had 28 fights. Twenty-two of these he won; eight by knockouts, two were draws, and he had four losers. Tiger Nelson, Jack Allen, Pop Deliman, Meyer Shapiro, Harry Powers, Babe Schwartz, Larry Socko and Young Taylor were kayo'ed by Hossie.

Sailor Andrews had an 8 round decision over Johnny, and the two also fought two 6 round draws. Willie Walker, Doc Conrad and Little Boy Blue had victories over Hossie.

A casual conversation with Mr. Hospidor, one day, acquainted me with his background as a leading boxer of this area, and, after pursuing this bit of information further, I learned that he was, at one time, a leading contender for the light-heavy weight class. In fact, from bits gathered here and there, John was the champion of his class in this section of the country. His record, as stated above, seems to attest to this statement.

During an interview with him I was able to garner a lot of information concerning the sports world of this era (1924-29) and will pass along his memoirs to the best of my ability.

When asked how he became a flighter, John answered, "I was always interested in all sorts of athletics and sports, and being sort of an athlete, I took to fighting in order to make spending money. I graduated from Vocational School, where I learned the trade of a machinist, but I soon discovered that when I started to fight in the main bouts, 8 to 12 rounds, I could earn enough money to make it unnecessary to work at my trade."

Mr. Hospidor, who is a well-spoken and soft-spoken man, and a true gentleman, in every sense of the word, told me, without any false modesty, of some of his experiences in the ring and out of the ring with some of the luminaries of the sports world.

with some of the luminaries of the sports world. "Tiger Nelson", said Hossie, "Was the big-man in the light-heavy weight class at this time and he was knocking out every contender he fought. In fact, he knocked out one of your South Amboy lads, Sturdy O'Leary, and Sturdy was a good boy in the ring. Anyway, Sailor Andrews was slated to meet the Tiger, but, for some reason or other, he was unable to appear on the card, and I took his place."

When asked how he made out with Nelson, Hossie said, "Well, I was fortunate enought to knock him down about eight times, and, in the eighth round, I knocked him out I was very lucky."

knocked him out. I was very lucky."

"With Sailor Andrews," Hospidor went on, "It was a different story; strictly a Mexican stand-off. In those fights we each won a decision and had one draw".

When asked to comment on some of the leading lights in the sports world during his time, Johnny said, "I was a sparring partner for Maxie Rosenbloom. Now there was quite a person! Maxie was a real slipstick and slapstick fighter. Always on the move. Always active. Always "on-stage"! A lotta laughs. I also sparred with Mike McTigue, the light-heavy weight champion, and Harry Wills, one of the leading contenders for the title. I knew Gentleman George Ward, but never had any action with him. It was during this period I had an opportunity to become a sparring partner for Gene Tunney when he was training for his fight with George Carpintier."

(Note\* I will have more on McTigue and Ward in a

forthcoming column.)

Hospidor continued, "I'm not going to reveal his name, but I must tell you something funny about one of these gentlemen I met during my fighting days. I was waiting

gentlemen I met during my fighting days. I was waiting in the ring for him, and, when he appeared, he tried to make his grand entrance by jumping over the ropes. He tripped and fell flat on his face. Incidentally, I won that fight which took place in Highland Park."

(These Highland Park fights were held in the Masonic

(These Highland Park fights were held in the Masonic Temple which was destroyed by fire two years ago. I was able to obtain the ring bell from the ruins, and it is now in the recreation room of a friend of mine here in South Ambey.)

"When it comes to Mickey Walker," Johnny went on, "He was a fighter's fighter. I remember when Ray Bolger brought him to the forefront. He became the champion of the welter-weight division by finishing off all contenders and decided to move on up to middle-weight, light-heavy weight and heavy weight. During this time he changed managers, placing himself in the hands of Jack Kearns, who had brought out Jack Dempsey. Kearns, along with Tex Rickard, arranged for the first million dollar gate in the history of boxing. This was the match between Dempsey and Firpo at Boyles 30 Acres in Jersey City. During this period, Mickey lost his money via high living but he never lost his art of fighting. He still remained the ferocious "Toy Bulldog."


