Annual Reports Read and Approved

-Forty-Eight Marriages the Past Year—The Approval of I. V. P. Slover's Bond as Plumber Held ed by Board.

The Board of Health held its final neeting of the year on Tuesday evening in the City Hall. Exclusive of the auditing of the annual reports the chief item of business transacted had to do with Mr. P. J. Monaghan. From the discussion it seemed that Mr. Monaghan had ordered one of his plumbers to do a piece of plumbing work in the residence of Frank Monaghan on John street without first obtaining a license or filing plans with the inspector for approval, as provided by the city code. The plumbing inspector had discovered Many Men Seeking the job before its completion and had ordered work stopped. Mr. Hulse reported the matter to the Board and also stated that Mr. Monaghan had not as yet made any move toward. securing a permit or filing plans as per instructions. In fact the commands of the inspector had apparently been wholly ignored.

After discussing the matter at some length the Board decided to uphold the inspector and accordingly instructed him to see that the requirements of the code were enforced even if recourse to the courts was necessary to insure this result.

The members of the board present were: President L. S. Dill, and Messrs. J. W. Mahoney, Daniel Salmon and C. S. Buckelew. Also Secretary Thompson, Registrar of Vital Statistics Mason, and Treasurer Coogan. The terms of the board members ends with the dawning of the New Year but there are rumors to the effect that they will be re-appointed. The economical and efficient transaction of the affairs of the Board of Health during the last two years is a silent recommendation in their favor.

The report of the Registrar of Vital Statistics showed a total of fortyeight marriages, two hundred and twelve births and one hundred and twelve deaths during the past year. Of this number fifty-five were more than fifty years old, eighteen over thirty, two between the ages of fifteen and thirty, and thirty-seven under fifteen. The report was approved and placed on file upon motion of Mr. Salmon to that effect.

The report of the plumbing injobs inspected, certificates being isthis number thirteen were his own jobs for which no compensation had aforesaid results. been made by the board for their inspection. Attention was called to this feature by the secretary and discussion brought out the fact that the inspector had never presented any bill for the inspections made on his own work. While the Board thought that he should be compensated just the same as if it was some one else's work, Mr. Hulse did not feel that way about it. After spending some time in endeavoring to persuade the plumbing inspector to see it from the feet of planking and two string Board's point of view the matter was

The secretary's report showed a otal of thirty-one permits issued, sixteen milk licenses, eighty-two plumbing permits and a total of two hundred and twenty-one dollars received from permit fees.

The monthly report of the treasurer showed forty-nine dollars received and disbursements to the amount of sixtyremaining being one hundred and thirteen dollars and fifty-two cents. The annual report was also submitted filed.

The bond of I. V. P. Slover, which was laid over at the last meeting, was again brought up. After some discussion it was again laid over for future consideration. This action was taken, it was plainly brought out, not because of any animosity toward the bondee in question but simply with a desire to clear up the matter of issuing permits to irresponsible plumbers. ONE HUNDRED AND FOUR VESSELS ENTERED PORT

The report of the health officer of the port of Perth Amboy to the State Department of Health for the year ending October 31, 1915, shows that during that year 104 vessels entered the port as compared with 110 the preceding year, and 139 in 1913. The reduction of nearly twenty-five per cent. in the number of vessels entering the port is attributed to the unsettled conditions in Mexico and Europe.

The reduction was most marked in the sailing vessels of which there were fourteen during the past year, fourteen in 1914, and forty-three in 1913. The fees collected and turned into the state treasury amounted to \$440 during the fiscal year of 1915, \$492 during the preceding year and \$522.50 in 1913.

The health officer of the port is under the supervision of the State health service to prevent communicacountry through this port. After deducting fees collected and turned into the state treasury, the net cost \$1,000 per year.

COAST GUARD CAPTAIN RETIRES.

RIVER OLDER THAN THE MOUNTAINS IT DRAINS

The guidebooks to western travel issued by the United States Geological Survey explain some things which at first sight seem inexplicable. How much more interesting it is to see something of which you know enough to understand and appreciate its wonders. Odgen Canyon, a deep cleft through the towering . Wasatch Salt Lake, is one of the show place: along the Oregon Short Line, yes many of the thousands of people who have viewed its beauties would have enjoyed them more had they first read the little statement of geologic history given in the Geological Survey's guidebook of the Overland Route.

Ogden Canyon, a deep notch with bare cliffs of hard pink quartzite on both sides, was cut in the solid rock by the river which flows through it. Running water carrying sand and gravel acts as a saw or file and, given time enough, can cut through the hardest rocks. Ogden River was flowing west along its present course before the lofty Wasatch Mountains came into existence. The raising of the mountains went on slowly for ages, so slowly that the river kept its place by cutting down its ever-rising bed, carving a deep and narrow canyon straight through the block of the earth's crust as it rose. In no other way can we rationally account for a river rising on one side of the range and flowing directly across it. Movement of the mountain mass has continued down to the present timeat least there has been recent disturbance along the base of the Wasatch Range, as is shown by faults which traverse the lake deposits and the modern alluvial aprons. Some of the breaks are so new as to be devoid of vegetation. The upward movement of the mountains has been so continuous that the river has had no opportunity to widen its valley, a task which it will begin as soon as the mountains cease rising. (Overland

This is because of the fact that such large amounts of the oats sold in this vicinity go for seed that it is well worth while to pay the additional five cents.

Now let us see what the farmers gained by so treating the seed. First, they have gained twelve bushels in yield per acre, which means \$5.40. Next, they have gained five cents additional on the other thirty-eight bushels which amounts to \$1.90. This gives a total increase value per acre of \$7.30, and the cost of treating the seed has been well within thirty cents per acre.

By thus treating the seed, these farmers have made an excellent profit alone that has been worth the interest on the land, and several times the inconvenience.

There are other savings by this treatment. Several times this year my attention has been called to the condition of barns where the smutty oats were being threshed. Crocheted buttons are extensively used this season, and those that are handmade have a distinctive charm all their own. When you are clever enough to make these buttons yourself you solve the difficulty of shopping for. unusual shades to match gowns and

come in almost every color, as do wool

and mercerized cotton. The crocheting is put over wooden molds, and these molds come in various shapes and sizes-square, round, oblong or oval-and silk, wool or mer cerized cotton can be employed with equal success, the material used depending upon the use to which the buttons are to be put. Those that are covered with silk can be used for ornamentation, as well as for pure utility, but handmade sweaters this season are showing buttons covered with the same material of which the sweater itself is made, either wool or silk. Buttons covered with mercerized cotton have infinite possibilities, for they can be used on all wash fabrics, as they launder beautifully. These buttons are quite simple to make, the main secret being to crochet tightly, so there will be no spaces between the stitches, revealing the wooden mold beneath.

Start with a chain of three stitches join, and into this ring put eight single crochet. Into every second stitch of these eight stitches put three single crochet. This will start the four corners. On the next row put three single crochet into every fourth stitch, which will bring it to the middle stitch of the three stitches in the row be low. Continue around, increasing two stitches on each side, until you have made a square large enough to cover the top of the mold. Then erochet two rows without increasing at the corners. Put in the mold and begin to decrease by skipping every fourth stitch. Do this for several rows. Then skip every third stitch, then every second one, until you reach the center. A row of single crochet around the central stitch forms a fine shank and makes it easier to sew on, as well as to button.

For round buttons start with chain of three stitches, join, and into the ring put eight single crochet. Into each of these eight stitches put two single crochet. On the next row put stitch, then into every third stitch, regulating this by keeping the circle perfeetly flat. When you have crocheted enough to cover the top of the mold crochet two rows plain without adding any stitches. Fit this on the mold and begin to take off, skipping first every fourth, then every third and then every second stitch until you reach the center. The covering should fit the mold very closely, so this may have to be

modified somewhat. To make oval buttons start with a a single crochet into each stitch of the chain. In the last stitch put three single crochet and continue on around on the other side of the chain, working three single crochet into the middle stitch on the other end. Work on around, putting three single crochet into the middle stitch of each end. If it does not lie smooth put in four stitches instead of three on each end. When you have worked enough to cover the top of the mold make two plain rows all around. Insert mold and begin to take off by skipping every fourth stitch, then every third and every second stitch until it is finished. Then work one row around the middle stitch as a shank. These seals last year helped to support thousands of needy tuberculosis patients and to give them a chance for life. They provided for many visiting nurses, whose hundreds of thousands of visits brought instruction and cheer to numerous patients. They helped maintain dispensaries in scores of cities from the Atlantic to chain of four stitches, turn and work the Pacific, where thousands of consumptive patients received free treatment, aid and advice. 

NEW JERSEY BRINGS SUIT

FOR \$2,437 HOARD BILL Suit to recover a board bill of \$2,437.16 was instituted in the Supreme Court at Trenton on Tuesday by Attorney General Wescott against Daniel Buckley, formerly of this city, but now an inmate of the State Hospital in Trenton. Buckley was committed to the institution in June, 1909, by Patrick H. O'Neill of this city, then his guardian. O'Neill died about one week after Buckley's commitment and the state has received no remuneration during the six years and a half he has been at the institution,

Buckley recently fell heir to property said to be worth \$2,800 and it is the intention of the state authoritles to recover the amount of his board and clothing bill from this bequest. Although Buckley cannot be mado a direct defendant in the litigation the suit will include an application for the appointment of a guardian against whom the action will then be directed. Annexed to the bill of complaint is an itemized statement of all clothing and other articles furnished to Buckley since he has been at the institution.

THE BROAD PASS REGION OF ALASKA.

The Broad Pass region of Alaska, which has long been considered a possible source of mineral wealth, has taken on additional interest since the announcement of the route chosen for the new Government railroad connecting the Pacific coast with the interior of Alaska.

In anticipation of the probable demand for information about this region the United States Geological Survey began the work of mapping its topography and geology in 1913, and now presents the results of the work in Bullentin 608, by F. H. Moffit. "The Broad Pass Region, Alaska."

Broad Pass is the western part of a wide glacial valley which is bordered by steep, straight mountain walls and which lies parallel with a great east-west range on the north and connects the upper valleys of Chulitna and Susitna rivers. Copper prospects, too, have been discovered in several parts of the region, and at one place, Coal Creek, there is a small area of coal. Riddle, New Brunswick, \$178,706.74; M. Irving Demarest, Sewaren, \$180,523.36; Meagher & Smith, Perth Amboy, \$187,448.95; T. F. Dunigan, Woodbridge, \$187,983.34; H. N. Scott Contracting Co., Cranbury, \$186,821,98. The contract was not awarded.

H Chint2 Room for Daughter

In the average home the only room which the daughter of the house can claim as her own is her bedroom.

This should be us dainty as possible, signifying girlhood in all its freshness and beauty. Unfortunately many girls believe that daintiness costs money and pass it by on the plea of a small pocketbook. Daintiness, as a matter of fact, can be achieved for a very small amount of money, provided one is willing to spend some time and not a little thought on the decoration of one's bedroom.

Pink and blue have been the colors long honored as the young girl's, but the young person of decided character who feels that these pale tints do not reflect her vivid personality may choose in these very modern times cubist and futurist colorings and, with the aid of some of the new and artistic chintzes. may achieve a very stunning effect.

The furniture par excellence for the girl's room is finished in white enamel, and if you are not fortunate enough to possess this sort you can easily change what you have at hand by a can of white paint and one of white enamel. Painting is by no means easy work, but it is work which many a girl has accomplished successfully at home. It will be necessary first to purchase a can of paint remover so as to take off as much as possible of the original stain. Then give the pieces of furniture two or even three coats of white or cream paint and finally one of white or cream enamel. This should be allowed to dry thoroughly before an attempt to use it is made.

Now, if your bed is a wooden one you can produce a very quaint effect by pasting over the head and base boards chintz in a pretty design. This should be cut to fit the boards exactly and edged with braid to match the chintz, the whole being glued flat on to the head and base boards, or brass headed tacks placed at one inch intervals can be used to hold the chintz. Some girls have created a very pretty effect by cutting out flowers or birds from chintz and pasting these designs at conventional intervals on the base and head boards.

The dressing table can be made very pretty by the aid of chintz, and if you want a dressing table don't despair. Just make one. "How?" perhaps you ask. It is really the easiest thing in the world. If there is a fair sized table somewhere in the house which is not used for any particular purpose claim it as your own and use this as the foundation for your dressing table. First it must be coated with white or cream paint or enamel. Then fit a cover of the chintz over the top and sew a ruffle of the same around this flat cover. The ruffle should be only three or four inches long and should be quite full, so that it will frill prettily. Over the top of the table should be placed a thick piece of glass, which you can purchase and have cut to fit at any glazier's. This will be the most expensive item in the making of the dressing table—it will probably cost \$4 or \$5-but this money will be well expended, for it saves the top of the table and the chintz from dirt and wear.

Now comes the question of the mirror over the table. In the basement of any of the big department stores a cheap mirror can be purchased for \$1.50 or \$2. This will have a brown or imitation mahogany frame and will not be a thing of beauty. But the glass will be fairly good, and the frame can be covered. Remove the nails which hold the back of the glass and the front of it together, take off the frame and cover neatly with the chintz, gluing ment in twisting scabbards of rolling it flat to the surface and allowing an inch or two to overlap to the back on either side. When this is quite dry put back on the glass and fasten the back to the front with the nails which were removed previously. Hang over the mirror and complete the charming effeet by purchasing two white enamel candlesticks which should be topped by

cainty shades made from the chintz. To carry out the color scheme drape the windows with thin silk mull in a white or cream shade, at 25 cents a yard, and sew a band of chintz to the edge of the curtains, or use the mull curtains plain, edging with a bit of lace, and introduce the chintz effect in a short valance at the top of the win dow. Do not, however, leave over curtains of the chintz. They shut out too much light and air, and a bedroom needs as much of these as possible.

Egg Values.

American cooks use the egg white more than the egg yolk, but how true is the instinct of the European cook in preferring the yolk even if the white cannot be utilized (he generally makes lady fingers or some of the other so called "biscuits" with it) can be seen by studying some of our most recent scientific books on foods.

An expert says of the egg yolk, "The yolk is a much more concentrated food material than the white, containing in a given weight about seven times as much energy, as well as larger amounts of protein and of the chief mineral matter."

A great European doctor who recommends yolks of eggs with oatmeal porridge has wonderful things to say about the food and curative value of eggs and especially recommends for anaemia spinach and eggs, instead of "taking expensive medicaments and artificial preparations of iron."

Things went on for a time, and then one morning Lombard street awoke to find that the yellow sign had disappeared and that inside the window of the parlor hung the meek legend:


'WasHinG doNe Here." But Lombard street would have none

LIMELIGHT

al Maurice Sarrail of the French Army.



General Maurice Sarrail, who has commanded the French land forces at the Dardanelles since early in August, 1915, had won recognition for military skill before being named commander in chief of the army of the orient. When the forces of the kuiser were making their first onslaught into France General Sarrail commanded the Third French army, which at that time faced northwards, with its back to the fortress of Verdun. Under pressure of the German rush General Sarrail's army bent around Verdun, yet held a firm and unbroken line that effectively stopped the advance of the German center. General von Kluck, in command of the German army at the extreme western end of the line, was forced to swing back, and then General Joffre saw that the time had come to fight the great battle of the Marne. Sarrail had saved the day.

General Sarrail first received milirank of captain, he was appointed to the staff of the Seventeenth army corps. Several years later he was attached to the staff of the military governor of Lyons, the headquarters of the Fourteenth army corps. He was made a lieutenant colonel in 1902 and eight years later was appointed director of infantry at the war ministry. The next year General Sarrail reached the rank of general of division, and in 1914 he was given command of the Eighth army corps. This is the position he held just before the outbreak of the war.

The former French commander at the Dardanelles was General Gourand, who was severely wounded and forced to return to France.

In order to secure a better balanced organization, effort has been made to carry out the research and extension, work under a number of projects. The control work in fertilizers, feeds, insecticides, and farm seeds furnishes a protection for the farmer against the manufacturer and dealer. The research work is of real scientific value and has done much to make agricultural a more profitable industry, Through its extension work the station is brought into close contact with the farmer, who is thus enabled to benefit directly from the station's activities.

Metuchen Home Gets \$5,000 Gift.

The bulk of the estate of Mrs. Sarah A. G. Skinner, of East Orange, is left to the Episcopal Church under the terms of her will as filed and G. Stickel, Jr., at Newark last week. The Metuchen Home for the Aged is left \$5,000. The estimated value of the estate is \$500,000. Bequests are made to many relatives and friends, including one of \$20,000 to Margaret S. Jackson, who was a domestic at the Skinner home.

St. Barnabas' Hospital receives \$7,-000 and \$5,000 goes to Christ Episcopal Church of Newark, to establish an endowment fund for the rector's salary.

The residue of the estate after the various other bequests have been made will be converted into cash and divided into three equal parts. One part will be given to the Domestic and Foreign Missioinary Society of the Episcopal Church of America; a second part to the American Building Fund Commission, also an Episcopal organization, and the third to the general clergy relief fund for aged and infirm Episcopal ministers, their widows and orphans.

Rev. Dr. Edward Wall, professor emeritus of literature in Stevens Institute, Hoboken, died at his residence, 186 Park avenue, Orange, Suntwo days. Although ninety-one years old, Professor Wall enjoyed comparatively good health until last Friday, when he was stricken with pneumonia.


