No Tax Increase in City Budget

PERTH AMBOY — Perth Amboy's \$42.9 million FY 2002 municipal budget continues to provide tax stabilization for the sixth consecutive year, while conducting millions of dollars in improvements and maintaining the vital resources for public safety, enabling Code Enforcement and Public Works Departments to deliver essential services.

732-283-0114 1140 OREEN STREET, ISELIN city's redevelopment efforts, have increased city revenues and generated a \$2.8 million surplus from last year. Augmenting this surplus is the accelerated tax sale law, which brought the city's tax collection percentage to an all-time high of 99.17 percent.

- Most notably, the city has realized \$21.6 million in new tax ratables over the last two years.
- State Aid is up by \$374, 188.
- Overail, revenue sources other than property-taxes are up by \$1,617,740.

These and other revenue increases have allowed the city to continue focusing on quality of life improvements. Many of these areas fall under the watchful eyes of the public safety, code enforcement and public works department, and the FY 2002 budget allows for the following:

- Maintaining the full complement of uniformed police officers permitted by city code-125 police officers and funding to replace retiring officers.
- Maintaining the new table of organization for the fire department headed by the new Fire Chief together with a new Deputy Fire Chief and eight lieutenants and funding to replace retiring firefighters.
- Providing full-time **Emergency Medical Technician** coverage seven days a week, twenty-four hours a day with nine full-time EMTs to work with the paid, part-time per diem EMTs to assist the Volunteer First Aid Squad.
- Providing funding to hire a replacement fire inspector for the Department

of Code Enforcement.

 Maintaining the new park workers to properly care for the newly renovated Rudyk Park, Dalton Park and Willow Pond facilities.

To offset salary increases, the administration continues to aggressively pursue grants and non-tax revenue. During the past two years, the Urban Enterprise Zone's 3 percent sales tax revenue paid for improvements projects including street resurfacing, expansion to the marina, upgrades to water and wastewater facilities downtown sidewalk improvements. Over the next several weeks, Perth Amboy's City Council will have the opportunity to review the budget and offer suggestions or recommendations.

Record Number Of Farms Approved By County Board For Preservation

MIDDLESEX COUNTY -Twelve farms totaling almost 600 acres were granted preliminary approval for the Farmland Preservation Program by the Middlesex County Agriculture Development Board (CADB). Of these farms, two are from Cranbury, one in East Brunswick, three in Monroe, one in Old Bridge, two in Piscataway and three in South Brunswick. Mayor Peter Cantu of Plainsboro and Chairman of the CADB noted. The 12 farms receiving preliminary approval were the Simonson Farm on Cranbury Neck Road in Cranbury, the Barclay Farm on Ancil Davidson Road in Cranbury, Geerlings Greenhouses, Inc. on William Street in Piscataway, the Von Thun Farm on Ridge Road in South Brunswick, the Barnes

Farm on Schoolhouse Road in Monroe, Seven Kay Associates on Dey Road in South Brunswick, the Cornell Farm on South Washington Avenue in Piscataway, Farrington Farms, Inc. on Davidson Mill Road in South Brunswick, the Kovacs Estate Farm on Federal Road in Monroe Township, the Borowsky Farm on Federal Road in Monroe Township and the Miller Farm on Cottrell Road in Old Bridge.

Under this program, landowners may sell their development rights or easements on their farmland to the County. In exchange, the landowners agree to restrict their land to farming with a permanent restriction placed on their deed. The landowners maintain ownership of the farm and may sell the farm but it can never be developed. The program is funded by the State, County and respective municipality.

Participating farms must be in an Agriculture Development Area (ADA). The ADA delineates those lands which are in farmland assessment and which are determined by the municipality and the CADB to be areas which have high quality soils and where the municipality and CADB would like to see farms preserved. Both the CADB and the State Agriculture Development Committee (SADC) then prioritize the applications according to such criteria as quality of soils, percentage of tillable acres,

boundaries and buffers, the size of the farm, development pressure and local commitment to agriculture.

The development easement values are determined by two independent appraisals submitted by the County to the SADC and reviewed and certified by the SADC.

Middlesex County has preserved under the easement purchase program a total of 2,457 acres which represent 19 farms. Another seven farms, which encompass 436 acres, are completing the process and will be preserved within the year.



Middlesex County's Revolutionary War History

MIDDLESEX COUNTY — East Jersey Olde Towne Village's newest exhibit relates to the 225th anniversary of America's Revolutionary War. The exhibit, entitled A Time of Turmoil; the Revolutionary War in the Raritan Valley feaauthentic tures artifacts. images and maps. It opened August 26 and will remain on display until January 20, 2002. The exhibit brings the realization home to Middlesex County residents that pivotal

moments of the Revolutionary War occurred right here in our backyard.

Site Program Coordinator David Mandel, Assistant Museum Curator Mark Nonestied and Historic Site Liaison Layla Wuthrick planned, researched, and assembled this historical exhibit. "This exhibit is one of the first in what promises to be a remarkable anniversary period," Executive Director, Anna M. Aschkenes recently announced.

Among the activities planned around this commemoration is a lecture series specifically geared for A Time of Turmoil. On Sept. 9, historian and consultant, Ernest Bower presents Artifacts of the Revolutionary War Soldier, a slide presentation detailing the accoutrements used by the Revolutionary War Soldier. The lecture reviews artifacts on display. On January 20, 2002 Dr. Richard Velt, a Professor at Monmouth University and

Principal Investigator with Gannett Fleming, Inc. brings the results of an archaeological excavation of the British winter encampment occupied after the battles of Trenton and Princeton. Located in Raritan Landing, Piscataway, the site yielded an assortment of artifacts reflecting the soldiers' activities and daily lives. The exhibit and lectures are without charge and open to the public.

East Jersey Olde Towne Village is located at 1050 River Road, Piscataway. The Village is open Tuesday-Friday, 8:30 a.m. 4:15 p.m. with guided tours at 11:30 a.m. and 1:30 p.m. and on Sundays from 1-4 p.m. with a guided tour at 1:30 p.m. The historic site is accessible, large type version of printed materials and sign language interpreters are available with a two-week advance request. Assistive listening systems are available on site.

County Owner Of Invalid Coach Sentenced To Jail For Medicaid Fraud

MIDDLESEX COUNTY—One of the owners of an invalid coach company in Middlesex County was sentenced to 60 days in Middlesex County Jail, placed on probation for five years and ordered to pay \$42,153 in restitution after pleading guilty to defrauding the Medicaid program of approximately \$120,000.

Vadim Bouguslavskiy, 52, of Woodbridge, was sentenced by Judge Phillip Paley in the Middlesex County Court on July 31, according to Attorney General John J. Farmer, Jr.

Farmer said that Bouguslavskiy, along with Alexander Soyfer, 45 of Woodbridge, and Boris Milman, 49 of Edison, were the owners of A&B Invalid Coach, Inc., formerly located at 655 Amboy Avenue, Woodbridge.

The three individuals and the company were indicted on March

29, 2000, by a state Grand Jury and charged with conspiracy, theft by deception and Medicaid Fraud.

The three individual defendants entered guilty pleas and Soyfer and Milman, who were sentenced earlier, received the same sentence. All defendants were debarred from the Medicaid program for a minimum period of five years.

Insurance Fraud Prosecutor Greta Gooden Brown, added that this is the fourth sentencing in this matter.

In addition to Soyfer, Milman and Bouguslavskiy, Dr. Stephen Plinio, a Woodbridge Chiropractor who had an office in the same building as A&B Invalid Coach also pleaded guilty to Medicaid Fraud.

Plinio was previously sentenced to probation, community service, and ordered to pay \$5,000 in restitution.

This matter was presented to the Grand Jury and prosecuted by Deputy Attorney General

Francine S. Pozner, and was Medicaid I investigated by State Investigator Office of David Weinfeldt, both of the Prosecutor.



Patient's Right-To-Sue Legislation Becomes Law

"New Jersey residents today have won a small victory for better health care," said Assemblyman Wisniewski (D-Sayreville). "The right-to-sue is a fundamental pillar of our democracy because it enables the powerless to question the powerful. That's what this legislation does and I am proud to have supported it."

AREA — Senator Vitale,
Assemblywoman Friscia and
Assemblyman Wisniewski announced that Acting Governor
DiFrancesco signed into law
legislation to extend medical
malpractice lawsuits to HMOs
and commercial health insurers.

The legislators said the new law already is at risk of being undermined by President Bush and the Republican-controlled

House of Representatives, which has approved a so-called patients' rights bill that would give residents a limited right to sue. The District 19 representatives said the proposed federal bill would effectively preempt the new state law in New Jersey.

"There are two institutions who think they are untouchable: foreign diplomats and

HMOs," said Senator Vitale.
"Legislation that makes
patients the priority instead of
HMOs is long overdue. It's
time that health insurers are
held accountable for their
actions."

All three legislators voted in favor of the new state law that would provide medical malpractice lawsuit options for patients sustaining serious harm because of an HMO delay or refusal to pay for care.

Under the law-the Health Care Carrier Accountability Act-patients who believe that an HMO decision has placed their lives or health in immediate danger may file suit in state court against the HMO. In less clearly defined and less egregious cases, however, patients would first need to plead their case to a state-appointed medical panel before going to court.

The law excludes half of New Jersey's working population. The 2.7 million residents covered by employer provided plans regulated by the federal government are not protected under this law.

"New Jersey residents today have won a small victory for better health care," said Assemblyman Wisniewski (D-Sayreville). "The right-to-sue is a fundamental pillar of our democracy because it enables the powerless to question the powerful. That's what this legislation does and I am proud to have supported it."

New Jersey is the ninth state to adopt the right-to-sue legislation. The eight states that have passed similar measures into law include Texas, Georgia, California, Washington, Arizona, Maine, Oklahoma and West Virginia. Missouri and New Mexico have passed laws that utilize other, more limited, approaches to HMO lawsuit liability.

Democrats in Washington, D.C. have been pushing for similar federal legislation. However the Republicans have yet to allow the proposal to be approved in the House of Representatives.

City Receives \$500,000 Needed To Construct Bike/Pedestrian Path

PERTH AMBOY—Mayor Joseph Vas is pleased to announce that the City of Perth Amboy has been awarded an additional \$500,000 by the NJ Department of Transportation (DOT) to construct a rails-totrails bicycle/pedestrian path along an abandoned rail corridor. When combined with the \$500,000 that the DOT awarded Perth Amboy last May, the city now has the majority of the funding needed to begin the estimated \$1.1 million project that will run parallel to State Street between Hall and Pulaski avenues.

The funding will allow the city to convert the former NJ Transit rail corridor into a bicycle and pedestrian friendly path enabling residents to pursue non-motor transportation alternatives. Perth Amboy's project was one of only 39 chosen by the Transportation Enhancement Advisory Committee and

the DOT from among the 186 that were submitted. The goal of the committee is to foster more livable communities by easing traffic congestion, preserving and protecting environmental and cultural resources and promoting alternatives modes of transportation.

The design of Perth Amboy's project will do just that. The conceptual plan, created by Carr Engineering Associates of Perth Amboy, calls for the path to begin at the corridor of Hall Avenue and State Street and proceed along the abandoned rail corridor to Pulaski Avenue.

The project will have obvious benefits, especially for children in the area who frequently walk or bicycle. The path will provide a safe, automobile-free route for children attending the E.J. Patten School, which is located on Charles Street, two blocks from the corner of Hall and State. The path will also

provide access to Rudyk Park, near Pulaski Avenue, where a \$1.5 million renovation was completed last year.

The project also ties into the city's cooperative effort to revitalize a fledgling neighborhood and attract new private investments. The city has invested \$82,000 in Urban Enterprise Zone Assistance funds as part of a streetscape project that provided new sidewalks, landscaping and decorative lighting along Hall Avenue. The city also resurfaced the entire length of Hall Avenue.

Since then, both Shull School, located directly on Hall Avenue, and the E.J. Patten School have witnessed complete facelifts. A new privately developed, eight unit adult housing complex is under construction and Banco Popular recently opened a branch of its bank at the corner of Hall Avenue and State Street. The Perth Amboy Housing Authority also demolished its antiquated public housing high rise on Huntington Street and recently cut the ribbon on new scattered-site town homes located on Cortland Street, just off of Hall Avenue.

With everything now in place, the city expects to go out to bid on the project during the fall. Should the actual cost of the project exceed the total \$1 million grant amount, the city plans to use other alternative funding, such as the Community Development Block Grant, to cover the cost of the project without dipping into taxpayers' money.

"Back" To School Shouldn't Be A Painful Experience

Curbing Suburban Sprawl

As we head toward the November elections, suburban sprawl has already staked a claim as a front-burner issue. Homeowners worry about it. Elected officials, from the municipal level all the way up to the statehouse, debate how to stop it. Farmers have mixed feelings about it-wondering whether we can control sprawl without drastically reducing land values and the rights of private property owners.

Solutions for stopping suburban sprawl are complex. One perfect plan to stop sprawl-type over-development of New Jersey's rural and suburban communities does not exist. However, there are tools at our disposal to help direct the growth into appropriate areas while respecting the rights of those who own the land.

Planning Commission re-adopted the New Jersey State Development and Redevelopment Plan (SDRP) earlier this year. This document contains many references to planning and zoning tools. The Plan supports the viability of the farming industry as well as preserving open space for both recreation and agriculture.

Additionally, New Jersey already has one of the most aggressive land preservation programs in the nation. Both the Farmland Preservation and Green Acres Programs aim to preserve a combined one million acres of New Jersey's open space and farmland by the year 2010. With each acquisition (whether it's an outright purchase of the land, or simply the purchase of development rights) we come one step closer to For example, the State reaching our goal and protect

one more precious piece of open space from development.

Working together to find creative solutions that work for each community is the great task before us. But before gubernatorial candidates and those running for the legislature rush headlong to seek a magic formula, they need to know that there is no one-size-fits-all approach that will work from High Point to Cape May. They also must understand that tools exist to curb sprawl, preserve New Jersey's farmland and protect the rights of those who own open space-goals each of us should strive for.

With vision and a sense of fair play, we can make those tools work in each of New Jersey's unique communities.

9-1-1 Emergency Number Day

AREA-People in all facets of the 9-1-1 industry and beyond have observed September 11 as National 9-1-1 Day ever since President Ronald Reagan signed a proclamation in 1987 making September 11 [9/11] 9-1-1 **Emergency Number Day. That** proclamation recognized the importance of 9-1-1 and it's ability to save more lives and increase the public's confidence of local emergency response system.

Thousands of dedicated public safety dispatchers, call takers, and telecommunicators throughout the State of New Jersey provide dramatic life-saving services by talking distressed callers through CPR, calming hysterical crime victims, and make difficult decisions using limited information to save lives or reduce property damage on an daily basis.

The critical functions performed by both sworn and civilian personnel play a significant role in the daily lives everywhere. citizens .of Though this day is set aside for us to be honored; we would like to take this opportunity to raise public awareness about 9-1-1 in the community and the right way to use it.

When to call 9-1-1: To Report a CRIME, To Report a FIRE. To Save a LIFE.

Q: Can you call 9-1-1 to find out if children have school?

A: Please do not call 9-1-1 to get school closing reports. Other options are local cable channel, radio stations and some schools have a special phone number for parents to call. Others may have preset recordings about school closings and school delays. Check your school on notification postings but do not call the police.

Q: What happens if someone in your house accidentally dials 9-1-1?

A: If someone calls 9-1-1 by accident please stay on the line and explain to the Dispatcher/Call-taker who you are and what has happened. Do not hang up. Most cities and towns will still require a police officer to respond and confirm everything is OK. [this is for your safety}

Q: What happens when you call 9-1-1 from a cellular phone?

A: It is very important to state the type of emergency and where you are. Also give the 9-1-1 Dispatcher/Calltaker your name and cell number in case you lose your connection. If you don't know your location look for street signs, names on buildings anything to help a dispatcher locate you and send the proper assistance you need. Even the license plates of parked cars on the street can help us find you.

O: What if you need to call 9-1-1 but can't talk or don't want someone to know you called 9-1-1?

A: If you need to call 9-1-1 and cannot speak for any reason such as physical impairment, injury or an intruder or some type of domestic violence situation. Stay on the line. When the dispatcher asked is someone there? If you can tap the phone with your finger or whisper so they know you are there. But do not hang up, the dispatcher can hear what is going on in the background, if someone is fighting etc. and can send help etc.

Q: Do 9-1-1 operators know your information when you have a call blocking serv-

A: Communications personnel receive your information on an ALI screen. This provides us with your location. phone number name of the person who owns the phone. This feature over rides any call blocking you have added to your phone lines. Remember 9-1-1 is for emergency so this is a very helpful to both the communications officer and you the caller.

O: Is 9-1-1 the same as nine eleven?

A: NO never refer to nine one one [9-1-1] as nine eleven. A major problem has been found especially with children if they are taught nine eleven

and not nine one one children under a stressful situation when needing to dial 9-1-1 a child may in fact look at a telephone and try to fine a nine eleven button, or a eleven button. For this reason always call 9-1-1 nine one one.

O: If a wild animal is in your yard or on your lawn can you call 9-1-1?

A: We do live in an area where there still is some deer. wild turkeys, geese, raccoons etc. you should expect to see some wild life especially if you live near a wooded area. Unless someone is in danger at that moment from the animal you do not need to call 9-1-1. Find out if your town provides an animal control officer. In you dial 9-1-1 then. general use a regular 7 digit number for your police department and not 9-1-1. Remember do not let any one near the animal, do not feed it and try to keep your pets inside.

Q Does a loud party or violation of a noise ordinance mean you can call 9-1-1 if you are bothered?

A Loud parties, lawn mowers, revving engines, barking dogs or any offensive noise is not an emergency. You may notify your police department on their regular 7 digit phone line. On the other hand if there is a fight at that party, or drug use or under age drinking now you have crimes in progress and yes you can call 9-1-1.

Q: Can you call 9-1-1 during power or utility outages?

A: Unless you have a life threatening medical emergency, or you see or smell gas, sparking wires, smoke or any unsafe condition do not call 9-1-1. Call your utility company and advise them, there is no need to notify your police department, if you feel you must use the regular 7 digit phone number. The police department will not know when and if power will be restored and cannot get the

utility companies to respond any quicker.

Q: Do you call 9-1-1 for dead animals or dead crows?

A: Find out from your municipal building the proper department and phone number to be notified for dead animals. With the concern of West Nile Virus, the Health Department is usually the agency to be notified about dead crows[not Robins or Blue Javs just Crows]. In either case do not dial 9-1-1, if you are unsure you may check your local cable channel for information or the 7 digit non emergency number for your police.

O: What about hurricanes. storms, floods or tornadoes do

A: Unless you have a life threatening emergency or need medical attention do not dial 9-1-1, notify your police department on the regular 7 digit line.. Remember in situations like this your police department will probably be overwhelmed with real medical or life saving emergencies that need priority attention, you do

not want the 9-1-1 lines iammed with non emergencies. Yes especially notify them if your basement is being flooded and there is a chance that your water heater or furnace pilot, or electric may go under water. If you know it is under water or came home to find that it has been in water for a while dial 9-1-1, as this can cause a fire, carbon monoxide poisoning, or gas explosion.

I urge all to pay tribute and recognize these Remarkable & Dedicated Public Safety Telecommunicators in New Jersey and all over America for the efforts and heroism that is displayed by them on a daily basis.

On this day to honor the voice behind the scenes that make daily life and death decisions, help keep the Citizens, Officers Firefighters, Paramedics and other responding units safe, and to get them on the scene quickly to save a life or apprehend a suspect. For they are the Pony Express of the Police Department.

Rex Boynton, President of NATE stated, "NATE is not a goal in itself, but rather the means to a goal. That goal is ensuring the most proficient and professional technicians who take pride in their work. High Marks Given On Environment And Consumer Issues

STATE—Assemblyman Neil M. Cohen (D-Union), was given the state's highest rating for his support of consumer and environmental issues by a prominent government watchdog group.

According to the New Jersey Public Interest Research Group (NJPIRG), Cohen scored an 80 for voting on key legislation advocated by NJPIRG.

NJPIRG scored legislators' votes on transportation concerns, playground safety, clean water regulations and other pressing

state issues. The votes were cast from Jan. 2000 to April 2001. The non-partisan activist group—which labels itself a pro-environment, consumer protection and good-government organization—said the average Senate score was 79 percent, while the average Assembly score was 77 percent.

"A legislator's responsibility is to go above and beyond the call of duty to create a safe, healthy environment for the citizens of New Jersey," said Cohen. "And this entails introducing and supporting legislation that stands up to polluters and powerful interest groups preventing them from harming the public."

The votes used in the survey included: strengthening public access, reducing traffic congestion, weakening environmental review, allowing utility bailout, making playgrounds safer, supporting safe wells, increasing public access to water test results, repairing failing bridges, empowering HMO watchdog, and supporting clean water protections.



Protesters Oppose Name Change

SOUTH AMBOY—On Aug. 15, approximately 80 people marched in protest of the Diocese of Metuchen's plans to rename St. Mary Diocesan High School.

The 7 p.m. march was organized to follow the 6 p.m. Assumption Day Mass, and demonstrators tried to persuade parishioners to join in their protest.

In June, Bishop Vincent De Paul Breen surprised the school community when he announced that the

achool would be renamed in honor of Cardinal Theodore McCarrick. McCarrick, the archbishop of the Washington, D.C. diocese, was the first bishop of the Diocese of Metuchen.

Vince Higgins, a 1949 alumnus who spearheaded the demonstration, said, "There's too much tradition and heritage here to walk away while it's being trampled."

The name change goes into effect in September,

and new stationary and signs have been ordered, according to Brendan Ramos, associate superintendent for the diocese.

According to some of the marchers, people are thinking about giving less money to the diocese's capital campaign because of the decision to rename the school.
