# Legislation Seeks To Fully Fund NJ FamilyCare Program

STATE—Senator Joseph F. Vitale has introduced legislation that would compel the NJ FamilyCare program to re-open its eligibility low-income men and women with single coverage health benefits.

"When the Department of Human Services decided to deny coverage to men and women without dependents it made the wrong call," said Senator Vitale (D-Middlesex), a member of the Senate Health Committee and a sponsor of the legislation that created the program. "Now it's up to the Legislature to make the right one."

On Aug. 15, the Department entry into New Jersey's innova- and put the money towards pro-

FamilyCare program. Effective Sept. 1, many lowincome men and women without children were no longer accepted into the program.

"Unfortunately for New Jersey's most needy population, the Department waited until the Legislature was out of session before they took this drastic step," said Senator Vitale. "Even though we'll only be meeting a few times before the elections in November, I hope my colleagues will think about this issues and be ready to act on as soon as possible."

Senator Vitale's legislation would amend the FY 2002 budget to remove \$30 million announced new guidelines for from special legislative projects

viding FamilyCare coverage. The bill would also delete the language placed in the budget act that allows the Department of Human Services to cap FamilyCare eligibility.

"If my bill is brought up for a vote, it will give every Senator the opportunity to make a clear choice between pork barrel projects and the health care needs of our poorest citizens," said

Senator Vitale. "The conditions that allowed this decision to be made were created by a sentence hidden in a 300 page budget document cobbled together at the last minute in the back rooms of Trenton. This bill put the cards on the table and asks the Legislature what's more important-looking out for the needy or looking out for themselves."



The mood of the normally festive evening was made somber in the aftermath of the terrorist attacks this past week.


In his remarks, Wisniewski said that "In the weeks and months following this horrible tragedy, we will need to look at each other in the community for strength and solace. This tragedy didn't affect just one

group of people. It affected not only Americans of Polish descent but Americans of all races and creeds. Our entire community needs to work together, teach tolerance to our children, and rise above these acts."

The Dinner Dance was held at Knights of Columbus Hall in South River on Saturday, Sept. 15. At the dance, it was announced that the Middlesex County chapter of the Pulaski Day Parade Committee will not be marching in 63rd Annual Pulaski Day Parade out of respect for the families of the more than 5,000 people missing from last week's terrorist attacks in New York City, Washington, D.C. and Pennsylvania. The Committee further announced that in lieu of marching the proceeds from their Annual Dinner Dance will be donated to the American Red Cross for disaster relief.

Thousands of Polish Americans and their friends come out for the Pulaski Day Parade and march up Fifth Avenue in New York City on the first Sunday of October each year. The Parade is a celebration of Polish heritage and ancestry.

The Pulaski Day Parade is scheduled for Sunday, Oct. 7, but it unclear whether the Parade will be held in light of the ongoing rescue efforts in New York City.

# Senior Computer Program Receives National Recognition

WOODBRIDGE—Local efforts to bring computers and Internet access to the senior community have received national recognition.

Mayor James E.
McGreevey has said
Woodbridge Township partnered with the Housing
Authority to bring intergenerational computer learning to
senior residents who had little
or no computer knowledge.

"Teachers and students from Woodbridge High School came to the agency's Campus of Learners program and worked one-one-one with more than 50 seniors," said Housing Authority Executive Director Donna Brightman.

The Campus of Learners program, which opened in 1999, was established to provide educational and employment education and assistance to Housing Authority residents seeking higher levels of employment.

Located in the Authority's Administration Building on Bunns Lane, the Campus serves as a base for computer and software courses, small business entreprenuership training and educational opportunities.

"The new high-speed connections allow the Campus of Learners to conduct classes in which 10-15 students access the Internet simultaneously, an option which was not practical with individualized dialup service," added Information Systems Director Michael D. Esolda.

Esolda said additional connections can be added if the program expands.

The senior computer program is part of Woodbridge Tech 2000, a program that is providing computers and internet access in Township schools.

When Mayor McGreevey announced Woodbridge Tech 2000 in his State of the Township Address in 1999, he also proposed a plan to include the senior community as part of the effort to provide Woodbridge residents with the tools and facilities they need to keep up with the latest in technology and computers.

Since then, six computer workstations have been installed at the Evergreen Senior Center for training for seniors. The machines include Windows, office products and the Internet.

One computer workstation has also been installed at each of the six Senior Housing Buildings, also including Windows, office products, and Internet capability as well as cable modems for fast Internet connections.

## Targeting High Risk Groups First During Flu Season

AREA — In accordance with guidelines from the Center for Disease Control and Prevention, VNA of Central Jersey's 2001-02 influenza campaign will begin in November by targeting those individuals identified as belonging to groups at highest risk.

In May 2001, the Advisory Committee on Immunization Practices issued a report recommending that high-risk individuals be vaccinated until the end of Employee-based November. campaigns that target primarily healthy, younger populations were asked to postpone their campaigns until December so those high-risk individuals may be immunized first. The report

also stated that individuals might continue to be immunized through December and later, even if influenza is occurring in the community.

The CDC identified the following as high-risk groups for vaccination: persons aged 50 years or older; adults and children who have a chronic illness such as diabetes, heart disease, lung disease or asthma; children and teenagers (aged 6 months to 18 years) who receive long-term aspirin therapy and might be at risk for developing Reyes syndrome after influenza infection; women who will be in the second or third trimester of pregnancy during the influenza season;


healthcare workers and employees of nursing homes, chroniccare facilities or assisted living residences.

The CDC stated that during the 2000-01 influenza season, manufacturing problems resulted in a significant delay of influenza vaccine availability. As a result, a substantial amount of vaccine reached providers much later than usual. Because influenza vaccine is newly produced for each influenza season, numerous factors may affect manufacturer's vaccine production and distribution.

The VNA of Central Jersey intends to publish its 2001-02 flu schedule in the local media in October.



### Treasury, IRS Announce Relief For Victims Of Attack

STATE — The Treasury Dept. and the IRS recently announced initial administrative tax relief for individual and business taxpayers who are unable to meet their federal tax obligations because they were affected by Tuesday's terrorist attacks.

The IRS and Treasury are providing relief to all taxpayers - regardless of where they reside — who are directly affected by the terrorist attacks. For example, this includes relief workers, the victims on the airplanes, taxpayers whose place of employment is in a disaster area, and taxpayers with records

maintained in a disaster area.

In addition, the agencies are providing relief to all taxpayers in the five boroughs of New York City declared disaster areas by the President. They are also providing relief to taxpayers located in Arlington County, Virginia, home of the Pentagon, which was also declared a disaster area.

In the aftermath of Sept. 11's tragedy, the IRS and Treasury want to assure taxpayers, businesses and tax practitioners that they are working aggressively to monitor the situation and resolve other potential tax administration issues as they are identified.

Affected taxpayers who have an original filing deadline between Sept. 11 and Nov. 30 have an additional six months plus 120 days of time to file that return and make any payment due with that return. Taxpayers who are currently on an extension that expires between Sept. 11 and Nov. 30, will have an additional 120 days to file that return.

Affected individual taxpayers who face an estimated tax payment date on Sept. 17 may postpone that payment by including the amount with their final estimated payments for Tax Year 2001, which are due on Jan. 15, 2002.

Affected corporate taxpayers who face an estimated tax payment after Sept. 10 and before Jan. 15, 2002, may postpone that payment until Jan. 15, 2002.

In addition, for six months the IRS will suspend many enforcement activities — such as levies. seizures and summonses — for affected taxpayers.

Taxpayers who are entitled to the relief described above should add the following designation in red ink at the top of returns they file: "Sept. 11, 2001-Terrorist Attack." If they receive a notice from the IRS, they should contact the IRS as indicated on the notice to explain why they are entitled to relief.

Although the IRS cannot extend the deadline for employment or excise tax deposits, the IRS will provide relief for busi-

nesses unable to make these deposits because of the terrorist attacks. The IRS will waive penalties on tax deposits required to be made by these businesses between Sept. 11 and Oct. 31 if those deposits are made by Nov. 15.

The IRS will provide additional details on this relief in Notice 2001-61.

Due to the unprecedented scope and breadth of this tragedy. the agencies will continue to monitor the situation and may issue additional guidance as appropri-

The entire Treasury family extends its prayers and sympathies to the families, friends, government workers and others affected by this attack.

### Coping With The Financial Aftermath Of Terrorism

AREA — The acts of terrorism on Sept. 11 have directly impacted the lives of thousands of Americans who have lost a loved one and indirectly affected us all. One of the areas of people's lives that has been affected is their personal finances:

- Some people lost a spouse or partner who provided all or part of their household's income.
- Some people, who worked in lower Manhattan and elsewhere (e.g., Midway Airlines) lost their
- Some people also lost their health insurance, as well as their job. If their employer no longer exists, they have no way to access group health insurance on their own through the federal COBRA law
  - Some people have incurred

unanticipated expenses for hotels and meals while stranded away from home during airport closings or costs for alternative methods of

 All investors are affected by the impact of the terrorism upon financial markets.

Below is a list of financial tips during these difficult times or any other financial emergency:

Contact Your Creditors Immediately - If you will have difficulty paying your bills as a result of a loss of household income, let your creditors know now, before you become delinguent on bills. Tell them the circumstances that have caused you difficulty and negotiate for a reduced or delayed payment. Note the name of the person that you speak to and the date and follow up all phone calls in writing summarizing the agreed upon

Apply For and Obtain Available Payments - This includes life insurance benefits, compensation payments announced by airlines and government agencies, and final payments from an employer.

Dust off Your Resume - Unfortunately, for many unemployed survivors, there will not be a severance pay. Their company no longer exists. Experts suggest developing a one-page resume that stresses job skills, rather than chronological dates of employment. If you have samples of your work available on the Internet, add the Web links so those employers can easily learn more about you online.

Sign up For Available Benefits - This includes state unemployment benefits and any other payments available to unemployed workers through their union or trade association.

Seek Alternative Health Insurance - Check if health insurance is available through a spouse's employer, union, or professional or trade association. Another source of coverage, for uninsured people who qualify by income and family size, is the NJ Family Care program. For additional information, call 1-800-701-0710 or check the Web Site www.njfamilycare.org.

Reconstruct Records If Necessary - While some of the emplovers and financial firms that were affected in the World Trade Center collapse kept backup records at a secondary location, others did not. Workers whose employer no longer exists may need to organize and rely upon their own records to document their employment history or prove eligibility for benefits.

Reduce Discretionary Spending - This is the time to reduce household expenses until income stabilizes. Good candidates are "flexible" expenses such as food, transportation, and clothing.

Avoid Knee-Jerk Investment Decisions - An already volatile financial market before the acts of terrorism will undoubtedly become even more so as trading resumes. Remember that investing

is a long-term proposition and history tells us that there can be prolonged periods of declining stock prices. That is why stocks are not recommended for short-term (less than five-years away) financial goals. The stock market is very efficient and share prices generally reflect events such as this.

Budget For Unanticinated Expenses - Add the costs for alterna tive forms of transportation an other expenses to your household spending plan and adjust other items as need

Reach Out For Financial (As Well as Emotional) Support) -Many churches and community organizations are assisting victims of this terrible tragedy. Everyone in the country has been affected by this event in some way and the level of compassion and support is high.

### **Businesses Can** E-Mail Disaster Questions

AREA — The Internal Revenue Service today activated an electronic mailbox to provide assistance and answers to business taxpayers affected by the Sept. 11 terrorist attacks. Businesses can send their questions to corp.disaster.relief@irs.gov.

"Because of the breadth and scope of the tragic events of Sept. 11, taxpayers face many questions," said IRS Commissioner Charles O. Rossotti. "Businesses can get the answers about extensions and other tax relief stemming from these disasters by emailing their questions to us."

The e-mail address was established to respond to questions businesses might have that were not addressed in the technical guidance — Notice 2001-61 and Notice 2001-63. The notices explain the extensions and other tax relief available to those affected by the terrorist attacks and are available at www.irs.gov.

### New High School Graduation Test To Be Given For First Time In 2001-02 School Year

STATE — The new High School Proficiency Assessment (HSPA) will be administered as the graduation test of record to the state's eleventh-grade students for the first time in March 2002. The eleventh graders will have three opportunities to pass the HSPA to meet the graduation requirement. Students who do not pass the HSPA next March will have additional opportunities to be retested in the fall of 2002 and the spring of 2003. The HSPA will initially be administered in the subject areas of language arts literacy and mathematics. Additional subject

areas will be phased in over the important measure of accountabilnext several years. ity in our schools," said Com-

Also, the state's fifth- and eighth-grade students will, for the first time, take a test in social studies. Fifth graders will take the exam in Oct. of 2001, while the eighth graders will take the test in the spring of 2002. Both fourth-and eighth-grade students will continue to test in language arts literacy, science and math — the eighth graders in March of 2002 and the fourth graders in May 2002.

"I believe that our state's system of assessments is the most

important measure of accountability in our schools," said Commissioner of Education Vito A. Gagliardi, Sr. "We have worked very hard to craft rigorous academic standards that reflect what students ought to know and be able to do at the fourth-, eighthand eleventh-grade levels, and we have worked diligently to link a rigorous system of assessments to our standards.

"I believe that this system of standards and assessments will provide our children with a worldclass education that will prepare them for successful futures in college and the working world."

In the 2001-02 school year, the Department of Education will also for the first time disaggregate testing data. This will allow school districts to compare test performance within several demographic groups. The state will disaggregate data by race, gender, limited English proficient, special education and socio-economic group. The United States Department of Education requires that this information be produced. The data will allow school districts to analyze student performance so that curriculum and programs can be introduced that are designed to address deficiencies.

"This information will be a great help to school districts," said Jay Doolan, acting assistant

commissioner for Academic and Career Standards. "For the first time, gaps in performance within individual demographic groups can be addressed using hard data."

The new HSPA will be administered on March 5-7, 2002 for high school juniors. The HSPT will be administered from Oct. 2-4 for any retained juniors, seniors, adult high school, or returning students who still need to pass one or more sections of the HSPT 11.

The eighth-grade test (GEPA) will be administered from March 11-15, 2002 and the fourth-grade test (ESPA) will be administered from April 29-May 3, 2002. The social studies test for fifth graders will be given on Oct. 16, 2001.

### Neminations Sought For Horoism Scholarship

AREA — The Higher Education Student Assistance Authority (HESAA) is accepting applications and nominations for the 2002 Dana Christmas Scholarship for Heroism, which is designed to honor young New Jerseyans for exceptional acts of heroism.

Named after the Seton Hall University student who is credited with saving many lives during a dormitory fire at the school, the scholarship provides a one-time award of up to \$10,000 for up to five deserving recipients each year. Awards may be used at any eligible institution to pay for undergraduate or graduate education expenses. For any recipients who are not yet of college age, their funds will be held in escrow until they enroll in a postsecondary institution.

To be eligible for the schol-

arship, a recipient must be:

- a New Jersey resident (both at the time of the act of heroism and upon application);
- age of 21 or younger at the time of his or her heroic act; and
- a U.S. citizen or eligible noncitizen and registered with the Selective Service (if required).

### How to Apply

Candidates must complete a scholarship application form and submit at least one supporting nomination to be considered for the award. HESAA will also accept nominations made on behalf of another individual; however, an application completed by the candidate is also required. The submission of supporting documentation such as newspaper articles is encouraged. The deadline for applications and nominations is Oct. 15. The application/nomination

form is available by calling HESAA's toll-free hotline (800) 792-8670 or may be obtained from colleges, high schools, fire and police departments.

### Selections

Eligible candidates will be reviewed by a scholarship committee for selection of up to 10 semi-finalists. The Executive Committee of the Higher Education Student Assistance Authority Board will then select up to five recipients whose acts of heroism are deemed to be the most extraordinary as the final scholarship recipients. These individuals will be notified of their selection in writing and will be required to submit proof of enrollment at an eligible postsecondary institution before payment may be issued.

### Testing Helps Teaching

Congress isn't expected to come out with a final compromise over President Bush's education plan until September, and much of the disagreement centers around his proposal for annual tests, using the National Assessment of Educational Progress, or NAEP tests, as an "audit" of state standardized tests.

Opponents to using any national tests for any reason are an odd coalition of liberals and conservatives: Liberals seem opposed to anything with the word "test"; conservatives seem to oppose anything with the word "national." But on the basis of recent reports from around the country, it's clear that both need to put aside their opposition for the sake of our children.

There is a consensus that the NAEP exams are an accurate reflection of student achievement. And without a "national audit" of state tests by an accepted national tool, parents will be left to wonder whether their state's examination is a good one or not. Consider—

- \* Mandatory annual testing was first proposed by Senator Robert Kennedy (D-NY) in 1965. It was then that he urged that the new Elementary and Secondary Education Act include a provision that districts report testing results to the federal government. Unfortunately, because it was left to districts to decide, it didn't work and according to historian Diane Ravitch, the tests were spotty and not consistently applied.
- \* Having a national benchmark can reveal which standards work well and which do not: NAEP scores over the last decade reveal that in Virginia, where there is a rigorous set of Standards of Learning, the gap between high and low achievers has decreased. Meanwhile, in Maryland, where the curriculum and the tests trend more toward the "touchy-feely" constructivist approach, the gap between high and low performance has widened.
- \* This phenomenon isn't new: Because of NAEP, we know that many state tests really do not tell us anything about


how our children are performing. Even as far back as 1997. there were massive differences between NAEP scores and the state tests. That year, parents in South Carolina were told that 82 percent of the students were passing, but when they looked at the NAEP exam they discovered that only 20 percent were meeting a rigorous standard. The same "credibility gap" existed for other states: In Louisiana. there was a 70 percent difference in seventh grade math exams.

State tests-and a national audit of those tests-are vital to educating students in highpoverty, inner city areas. Research shows that "A" students in high poverty schools test at about the same level as "C" or "D" students in wealthy communities. For children in low-performing schools, an intense focus on well-defined. measurable educational outcomes is long overdue. Without a standardized test, there will always be a concern of college admissions officers and employment counselors: that if a student went to school in Harlem, the grades are going to be inflat-

Perhaps Education Secretary Rod Paige said it best in response to the charge that students will be "tested to death": "That's a charge made by people who feel that testing is somehow external to teaching. But it isn't. It's the other side of the same coin. If you don't assess where you are, what the students have learned or not learned, you're teaching in the dark. That's analogous to driving at night without headlights. Do you ever hear anyone saying we're teaching them to death?

This is perhaps the time of America's greatest challenge. We need to defeat the forces of evil and hate that would destroy us and our way of life. But in so doing we must never lose sight of the values that make us all Americans.

We must celebrate our diversity, not discourage it. We simply can't allow hate to invade and destroy us. Remember, where there is acceptance of

# First-Hand Account Of The Pentagon Attack And Its Aftermath

This is a letter written the day after the attack to Rear Admiral Mike McAfree by Lt. Chris Ludmer, USN who is Flag Lieutenant to Rear Admiral Donald J. Guter the Judge Advocate General of the United States Navy. It describes in detail the escape from the Pentagon.

As you already know by now, all of us in the front office made it out safely after [Sept. 11's] attack. I wanted to relate to you something of what we all experienced, from a first-hand perspective.

At 0900, Admirals Guter and Lohr, all the Aides and EAs, and several AJAGs were in Admiral Guter's office for the weekly AJAG meeting. We were discussing several issues, when word came in that the World Trade Center had been attacked. We turned on the TV in the Admiral's office and saw live the scene of horror as the second plane smashed into the South Tower. Everyone in the room let out a collective gasp, and stared in momentary disbelief. After coming to grips with what we were watching, Admiral Guter quickly took control of the meeting. While leaving the TV on, we moved to the next issue for discussion. Several minutes later, with a warm DC sun shining through the windows of what we all considcred was the unassailable fortress of our defense establishment, a deafening explosion sounded. Just as we heard the loud crash, a shock wave ripped through the building, shaking the walls and jarring our bones where we sat. "We're under attack," and "We've been hit." were the first audible responses after a split second of stunned silence as our minds came to terms with what our bodies had just felt. What we were watching on TV in New York had just happened to us. The plane struck the opposite side from where our spaces are, and still we were battered around with tremendous force. That should give you an indication of the strength of the blast.

Immediately, the word spread through this massive complex to evacuate. We all left the office, calm mostly because we were still in shock over what was happening. For the most part, the evacuation was orderly. But we heard shouts and screams, voices shouting "Oh my God!" and "Get the hell out! Out!" Panic was spreading formuch some, many restings in 41 directions through executions. One area of the Miding but lest power, was dark, Neck with choking smoke. d settles, and collegating officer and bulkboads were car-at throughout. Balls of flame

and swarms of debris shot through rings E, D and C at the affected area, tearing through bulkheads, people, and even the spirits of those anywhere in the building.

Through the mass of bodies. pressing against each other from every direction, I found my Admiral up ahead. We had been separated by the sweeping current of blues, greens and khahis. Fighting through the press, I reached him. He was calm and resolved. As we headed down the ladder well from the 5th deck, he told me to make sure we had everyone out. We had. We finally made it outside, through the river entrance. Crossing the grass yard with thousands of others, we felt the warm sun and saw ahead of us the gleaming white of the Washington Monument across the Potomac. Turning around, I looked upon a war zone.

Thousands were still pouring out of the building. From our angle, it seemed half the building was throwing huge clouds of black smoke into the air, covering much of the sky. After staring at our burning building for a few minutes, it was really setting in that we had been attacked. My mind thought of the trip to Pearl Harbor a few short weeks ago, and our tour of the Arizona Memorial. Was this what those sailors had felt on that day-the shock, confusion, surprise, and then horror at the slow realization that they had been attacked suddenly and without warning? I didn't know, but I imagined it must have been somewhat similar. The crowd assembled stared aghast ...the shock was fast turning to anger and a temporarily impotent desire for vengeance.

The soldiers and sailors were running past the throng, shouting for doctors, medics and corpsmen. They had turned the North entrance into a morgue, triage, and temporary care facility for the injured. There were many of them. Shortly after the call for medical help went out, word spread that another plane was detected headed straight for the Pentagon. The ETA was 10 minutes. Just as the World Trade Center was hit twice, so were we to be, it seemed. We were too close to the building. Orders were passed to get even farther away.

In a scene from a movie, literally thousands of Navy, Marine, Air Force and Army officers and enlisted ran from the building grounds, hopping bushes and low walls, jumping down steps two and three at a time. Along the river the hill slopes down away from the Pentagon, and it was there, in that natural trench, that

thousands threw themselves, hitting the dirt and laying down...taking cover from the imminent second attack. Just as some were screaming, "Why do we have no air cover!?" F-16 fighters out of Andrews AFB. their wings visibly packed with missiles, screamed overhead. They flew in circles over the Pentagon and the District, with word, we were told, to shoot down any airliner that came into the area, no matter how many were onboard. I looked up and thought, this indeed was war...Thousands of my fellow citizens were dead in New York. my headquarters was burning and collapsing in smoke and rubble before my eyes and jet fighters were flying combat air cover over our capital for the first time in history. I myself saw two people collapse outside from apparent heart attacks as we took cover and awaited the imminent second attack. Thankfully, it never came. Personally, I suspect that the plane that crashed outside of Pittsburgh was headed not for Camp David, as the press had speculated, but for us at the Pentagon.

Sirens from police cars, fire ambulances engines, and screamed everywhere. Helicopters, military and police, filled the sky overhead and deafened our ears. Buses packed with medical personnel brought in from Bethesda and Walter Reed skidded around armed barricades and raced to the center of the carnage. We ran into RADM Craig Quigley, the Pentagon spokesman, and he stuck with us for a while. He was as confused as the rest as to what was happening. Dozens of us surrounded a man who had a portable radio, thirsting for any news as to what was going on. A report came through, later contradicted, that the State Department and the Treasury had also been hit. No one knew what was going to happen next, or when the attacks might end. We were gathered outside the Pentagon, watching it burn, still felling the shock of the blast, and we felt impotent. No one knew what to do. We could only make sure others were safe, help those who were injured, and rage inwardly, pining for a deadly retribution. We had somehow survived a sneak attack while too many others working very close to us had paid with their lives. We would never be the same.

Late [that] night, Admiral Guter called me at home. His message was simple. "Chris, we're going in tomorrow." "Aye, Sir," I said. We sent the message to the rest of our troops. My apartment building is only a few blocks from the Pentagon, and I walk

here to work everyday. This morning, (Sept. 12) at 0545, in the same uniform I had worn when we were attacked, I headed across the street to my office. Parts of the building were still burning, smoke billowing upward in the pre-dawn hour. Police, military and civilian were everywhere, letting no one near the building without a Pentagon pass. But DOD workers, military and civilian, were heading in. We were sending a message..."You will not frighten us; you will not stop us no matter what you do."

Passing through security, I entered the south entrance of the building. Smoke and black soot were everywhere, a cloud choking me as I passed through. I walked through the NATO corridor, the end of which I could not see through the smoke. But I was not alone. Others were walking in alongside me, faces grim with determination. No one spoke, no one laughed. Only the echo of footsteps on the ash-covered floors could be heard throughout.


Passing through SECDEF corridor, the smoke cleared. I could see through the windows into the inner courtyard, jokingly referred to as "Ground Zero." It was no longer a joke, but had become reality. I stopped in my tracks and stared. Fire engines were in the courtyard. Smoke was still pouring off the roof and fires still burned on the opposite side. The

grassy areas of the courtyard were being turned into makeshift morgues, body bags covering the lawns under the trees laid out in rows like at the national cemetery not far away. They weren't full, but were obviously ready for what the rescue crews would find in our building once the collapsed wreckage was cleared away. All along the walk to our office, corndors were covered in black ash and cordoned off with yellow police tape. But I am here in our spaces, as is the entire front office. We smell smoke, we have soot all around, and firemen are yelling at us to leave, but we are here for now. It is amazing that we have power in our part of the building. I want to please Sir, ask you to pass on my thanks for all my friends down there who called my home and left messages for me yesterday. I could not return all the calls, and the phone lines in the area are still jammed and not working properly.

Please thank everyone for their concern and prayers. May God be with those who yesterday and today gave their lives in this, America's latest war.

PARALEGAL PROGRAM

The Central Intelligence Agency (CIA) Paralegal Program allows a small number of exceptionally qualified Paralegals to obtain a broad exposure to the practice of national security and intelligence law. Paralogals support the CIA's Office of General Counsel and are assigned to one Division, depending on the needs of the Office.

The CIA Office of General Counsel is responsible for advising the Director of Central Intelligence (DCI) on all legal matters relating to his role as head of the CIA, and his role as head of the U.S. Intelligence Community (which consists of CIA and all other intelligence agencies in the U.S. Government). Thus, the General Counsel, who heads the Office of General Counsel, is the principal legal officer for the CIA and the DCI's Community Management Staff (CMS). The Office of General Counsel also provides advice and guidance to those officers and employees within the CIA and CMS who have specific responsibility for the conduct of U.S. intelligence activities. It should be noted that the CIA is a foreign intelligence agency, not a law enforcement agency, and is expressly prohibited by law from having any police or law enforcement powers, or internal security functions.

The CIA Office of General Counsel handles, among other things, egal issues relating to foreign intelligence and counterintelligence activhes, international terrorism, international narcotics trafficking, nonproliferation, personnel and security matters, clandestine movement of materials and supplies, contracting, finance and budget matters, legislation, and both civil and criminal litigation. The Office of General Coussel consists of approximately 90 attorneys and 18 paralegals with a variety of backgrounds and experience.

A Top Secret security clearance and U.S. citizenship is required for all persons who work at the CIA. The CIA's personnel acreening process (which includes medical and polygraph examinations and a background investigation) generally takes between six to nine months to complete. Paralegals must possess a paralegal certificate.

Subject to the successful completion of the personnel screening process, paralegals will generally be paid at the entry-level rate of GS-09, Step 1, with growth potential through GS-12, Step 10.

# Finding The Disclosures In "Free" Internet Service Offers

AREA—You've probably seen the ads for "free" Internet service trial periods. Maybe you've even received a CD-ROM in the mail that promises hundreds of hours of free Internet service.

If you're in the market for Internet service, the Federal Trade Commission (FTC) wants you to know that some "free" offers may end up being high cost, long-term items. That's because important restrictions and conditions on these offers are not always disclosed clearly or conspicuously.

Most offers for "free" Internet service are valid for only one month. At the end of the "free" month, many providers automatically sign you up for their service, unless you cancel at the end of the free month. Unfortunately, you may not know that you have to cancel because some service providers hide this information—or don't tell you—how to cancel should you want to.

Costs add up in other ways, too. For example, if you sign up for service and the Internet service provider (ISP) doesn't offer a local phone number for you to dial in to, you'll have to pay long distance telephone charges to access the Internet. Some ISPs offer a "toll free" (800, 888 or 877) number to connect to the Internet. The FTC has found that some consumers have been charged five or six dollars an hour to use a "toll free" number.

FTC officials caution consumers to ask the ISP some key questions about their service and related conditions before using any "free" offers.

• Does the free access to the Internet last longer than one month? Offers for an advertised 500 free hours of Internet service

in one month would require you to be online for more than 16 hours a day to use all the free hours in a month.

- When does the one month of free service start? When you sign up? When you start using the service?
- Does the ISP automatically subscribe you to their service at the end of the free trial period? Do you have to cancel before the end of the free trial period to avoid being charged for service?
- How do you cancel service? Can you cancel online or by calling the service provider's phone number?
- Is there a local phone number for you to use to access the Internet? When you get the number to dial from the ISP, ask your local phone company if it's a local or long distance number. Make sure the back-up phone number you choose is local, too. If you have to call long distance for Internet service, chances are you will rack up big charges.
- If you sign up for service, are you committing to paying for the service for a year? Longer? Some ISPs require you to agree to pay for their service for at least one year and may charge a fee to cancel the service before your subscription has ended.
- when are you billed each month? If you decide to cancel service, you may want to do so before your billing date so you don't incur a monthly charge for service you don't plan to use. Remember that ISPs bill you before you use the service.
- If you cancel your service, does the ISP send you a notice? Get verification (e.g., cancellation number, email or letter) that your

account has been canceled and check your next credit card statement to make sure you aren't still being billed by the ISP.

If you think you've been misled about an offer of free Internet service, contact the Federal Trade Commission. The FTC works for the consumer to prevent fradudlent, deceptive and unfair business practices in the marketplace and to provide information to help consumers spot, stop and avoid them. 
