



Financial Certainties In An Uncertain World

AREA— "Financial certainties" are information that you can always know to be true, no matter what is happening in the financial markets. Below is a description of nine basic principles:

Regularly Will Get You To Your Goals—Savings has a cumulative effect. Compound interest over several decades is awesome. Start by contributing something to an employer tax-deferred retirement savings plan, even if it is not the maximum amount, and increase the percentage when you can. "Pay yourself first" at the beginning of the month rather than waiting to see what, if anything, is left later.

From Reaching Your Goals—Consider having no more than two credit cards and don't treat shopping as a form of recreation. There are two types of debt. "Good debt" is for investments for the future (e.g., college education and home improvements) while "bad debt" is for "disposable" expenses, such as meals and vacations, that are purchased with credit cards.

3. Diversification is the Best Way to Protect Against Investment Fluctuation—A common error is to have too much riding on one's employer: a job, a pension, stock options, etc. It is wise to invest in all assets classes (stocks, bonds, real estate and cash) and place money in different types of each asset class (e.g., small, medium and large companies).

4. If Something Sounds Too Good To Be True, It Is-Don't let the prospects of personal gain cloud your judgement. Just say no to deals that promise high returns and no risk. In a recent case, fraudsters promoted an investment that promised to pay a 300 percent return in 12 days. Many so-called "sophisticated" investors were taken in by this and lost money.

5. Your 401(k)—or Other Tax-Deferred Plan—is a Gift Not To Be Overlooked—Don't ignore the opportunity to invest tax-deferred through an employer plan, especially if there is a match, which is "free money." Personal savings can be a major source of retirement income. Most people do not want to lower their living standard in retirement.

o. You Should Have a Will—If you don't have a will, the state has one for you. A big roadblock for many people is naming key positions such as guardian and executor. It is important, however, to make an appointment to see an attorney and get it done. You can always change different sections of your will later if you want.

7. Sometimes Enough is Enough—It is not necessary to "beat the market" but, rather, to simply earn a return (e.g., 8 percent) sufficient to reach your own personal financial goals. Americans are very competitive by nature, however, and are always trying to earn better than average returns.

9. It Pays To Get a Regular Financial Check-Up -Like former New York mayor, Ed Koch, it is wise to periodically ask "How am I doing?" Financial advice is not just for the affluent. Components of a financial checkup include a cash flow analysis, a review of investment performance, including portfolio rebalancing, and a review of estate planning documents. 

Check-Ups

Important For Financial Heatlh

AREA—A financial checkup is as important as an annual physical with your doctor. Like a medical exam, a review of your finances can identify strategies to improve "financial fitness" and screen for potential problems, such as lack of a will or a high debt-to-income ratio. This article will discuss ten ways to assess the strengths and weaknesses of your financial situation.

Check-up Method #1 is financial quizzes. Rutgers Cooperative Extension's Financial Fitness Quiz is available online www.rce.rutgers.edu/money/ff quiz.asp. The quiz consists of 20 questions about various financial practices. Those with a low score indicate areas for improvement.

Check-Up Method #2 is financial goals. Goals should be SMART, which is an acronym for specific, measurable, attainable, realistic and time-related. Annual progress benchmarks should be established. Investments should be matched to the time frame for financial goals: short-term (less than 3 years), intermediateterm (3-10 years) and longterm (more than 10 years).

Check-Up Method #3 is a net worth statement. Net worth is assets (what you own) minus debts (what you owe). Assets have three categories: liquid (cash assets, such as a CD or money market mutual fund), tangible (personal property such as a house and car) and investment (examples: mutual funds and 401(k) plan). Shortterm debts are those that you expect to repay within a year (example: credit cards) and long-term debts, like a mortgage, last longer.

Check-Up Method #4 is the "Wealth Test." This formula, from the book The Millionaire Next Door, can be used to assess one's personal progress



based on two key factors: age and pre-tax (gross) income. Simply multiply these two figures together and divide by 10. This tells you what your net worth should be. Obviously, the higher the number relative to this benchmark, the better.

Check-Up Method #5 is an income and expense statement that analyzes past spending patterns. There are four components that are totaled for a month: income, fixed expenses (e.g., rent), variable expenses (e.g., food) and 1/12 the annual cost of periodic expenses (e.g., quarterly property taxes).

Check-Up Method #6 is a review of irregular expenses such as school tuition, property taxes, and vacations. List all expenses that come irregularly throughout the year. Then total each expense and divide by 12. Treat these expenses are monthly "bills" and set money aside for them.

Check-Up Method #7 is financial ratios. Financial ratios are developed by linking key pieces of information in financial statements.

Liquidity ratio is a measure of the adequacy of one's emer-

gency savings and is calculated by dividing liquid assets (from a net worth statement) by monthly expenses (from an income and expense statement).


The ratio should be 3:1 or better. A debt-to-asset ratio is a measure of solvency. It is calculated by dividing total liabilities by total assets and should be lower than 1.0 and preferably .5 or lower (less than 50 cents of debt for every dollar of assets).


Check-Up Method #9 is a credit card check-up. Areas to consider are strategies to pay a lower interest rate (e.g., refinancing), whether certain credit cards could be cancelled, a recent review of your credit file for errors and evidence of identity theft, and obtaining your credit score.

Check-Up Method #10 is a tax check-up. Areas to consider are your marginal tax bracket, whether or not you are maxi-

mizing contributions to taxdeferred employer savings plans and individual retirement accounts (IRAs), and other taxreduction strategies such as deductions, credits, and low long-term capital gains tax rates on assets held more than a year. The next time you're scheduling a medical check-up, take time to assess your finances also. Music As Therapy

Music, for most of us, is very much a part of our daily lives. From the wake-up notes of a clock radio to the background in an elevator or at the mall. Music is usually so much with us that we sometimes overlook the power it can have. But for many mental health professionals, the magic of music is very evident.

A severely autistic child paces in a room, making a repetitive high-pitched sound. A music therapist enters, sits at the piano, and hits a deep, resonating chord. The little boy stops pacing then tilts his head in the direction of the piano. Within the next ten minutes he is modulating his cries to keep pace with the therapist as she moves up and down the keyboard. He doesn't say a word or make eye contact, but what has just occurred is a form of communication-the child's first.

Across town, in the dementia unit of a nursing home, an elderly man with Alzeheimer's can no longer carry on a conversation. However, when the first measures of a familiar recording are played, he starts singing, keeping perfect time and staying in tune with the music. Music clearly has power. Music is also a universal language. Some neurologists say that our response to it is innate and the preferences for different types

of music may be established as early as four months. More than one anthropologist has argued that music may have been the first art form, as our early ancestors experimented by hitting sticks together, blowing on a blade of grass, or attempting to mimic the songs of birds.

Every culture throughout history has made music. The hieroglyphics in the ancient pyramids for example, depict harps, bells, drums and flutes made from reeds. Music, then and now, has the power to "soothe the savage beast," make us smile and tap our feet or whip us into a patriotic frenzy. Most of us can name at least one song or piece of music that has the ability to move us to tears or bring back a memory of a special time.

Music therapists are specialists within the counseling and psychology fields who use music of all types to help people express their feelings. Listening to recordings, playing an instrument, writing music, or experimenting with rhythm are techniques that have been successfully used with a wide variety of populations, including individuals with mental retardation, head injury, autism, and schizophrenia. Sessions led by a trained music therapist have also been shown to benefit indi-

Oxford offers some helpful hints to make your summer meals and snacks more nutritious:

- For salads, be sure to use dark green leaves such as spinach or romaine lettuce. These are loaded with antitoxidants.
- Add beans to salads and soups to boost the protein content and enhance the taste and texture. Chickpeas, kidney beans, pinto beans, black beans and red beans are all healthy, nutritious choices.
- Don't get stuck in a food rut; choose from a variety of vegetables. Go for deep or brightly colored vegetables such as peppers, tomatoes, zucchini, spinach, squash, and carrots. Bright, rich colors are

a sign of highly nutritious foods filled with vitamins and minerals.

- Aim for a variety of colorful, fruits such as kiwis, different kinds of berries, tangerines and melons—the more color, the more nutrients.
- Adding grains to soups and salads will boost carbohydrate intake and help make the meals more filling and satisfying. Instead of plain white rice, try different grains like brown rice, bulgur, barley, kasha, millet or buckwheat, which have more nutritional value.
- For even more satisfying meals, toss lean chicken or grilled fish onto salads to add protein, vitamins, minerals and the heart-healthy omega-3 fatty acids.

AID/STD Hotline Advises On Travel For People With HIV/AIDS

AREA—As summer reaches it midpoint, more and more people begin taking the trips they planned for all year. Traveling, particularly to underdeveloped countries may pose a risk for illness

Bacteria, viruses and parasites can make a healthy person very sick. However, if you are immuno-compromised, you can become severely ill or even die. The Centers for Disease Control (CDC) offers several tips for travelers to lower medical risks for infections and for general protection.

• Before traveling consult your doctor. He or she may be able to provide useful information, may know of places where certain illnesses can be a problem, may know of doctors in the area that treat people with HIV, or may advise you on vaccinations you may need for the region you will visit or other precautions. Tuberculosis (TB) is common worldwide, so your doctor may advise you to get a TB test upon return. Remember

to take all prescribed medica-

- Be prepared. Common problems for example, traveler's diarrhea, can occur. Make sure you have appropriate medications for this problem, bring enough of your regular medications in case you cannot refill prescriptions overseas or you get "stuck' in a certain area and cannot get to a pharmacy. Be aware that some medications may need to be refrigerated. In some areas insect borne diseases can be a problem. Bring a supply of insect repellent that contains "DEET."
- Check medical restrictions. If you are leaving the country for an extended trip, make sure you know if the country you are visiting has special health rules for visitors. These rules can include vaccinations that may not be safe for HIV-infected people to take. Make sure all medical insurance is up to date and take proof of insurance when you travel. Know your insurance plan; some things may not be covered overseas.

 Food and drink. Food and water contain bacteria, viruses or parasites that can make you sick. Do not eat raw fruit or vegetables that you do not peel yourself. Do not eat raw or uncooked seafood or meat unpasteurized dairy products or anything from a street vendor. Do not drink tap water, drinks made with tap water or ice made from tap water or unpasteurized milk. Foods that are generally safe include steaming hot foods, bottled drinks, hot coffee or tea, wine, beer. If your doctor has you on a special diet, stick with it.

- Animal droppings. In many countries, animals roam freely. Animals may leave droppings on beaches or other areas; always wear shoes and protective clothing, sit on a towel or blanket to avoid direct contact with possibly contaminated areas. Swimming can make you sick if you swallow the water. Never swim in water that might contain animal waste or sewage. Only swim in "protected" areas.
- Prevent. Take the same precautions that you take at home to prevent giving IIIV to others. Remember, help is just a phone call away!

viduals in hospitals and nursing homes.

Studies find that music can produce measurable mood changes and for some can even be an effective antidepressant. Research indicates that certain types of music can lower blood pressure, decrease anxiety and in rare cases, even serve as a good way to decrease physical pain. When combined with art therapy, dance or psychodrama, music therapy can help individuals in ways that traditional "talk therapy" does not.

In the December 2001 issues of the Harvard Health Letter, it was reported that brain imaging studies showed that music "lights up" the sections of the brain that are responsible for

emotion and feelings. It's possible that musical memories outlast other forms of memory because so many parts of our brain are involved. When we put on our favorite CD on and sit back to listen, blood flows to the same areas of the brain that respond to pleasure-inducing stimuli such as sex. It's no wonder that music holds so much power over our emotions and can be retained long after other forms of memory are lost.

While there's no evidence that listening to Beethoven will cure Alzheimer's or listening to Mozart will make us smarter, music can have an important and therapeutic effect on us. It's unfortunate that with budget cuts so many schools, psychiatric hospitals, rehabilitation

facilities and nursing homes must consider educational and therapeutic music programs a luxury, as opposed to a necessity.

With its ability to help reestablish social interactions and involvement, a lack of music denies pleasure and a higher quality of life for many who are ill or elderly. Music is the most social of the arts. The German philosopher, Nietzsche, expressed it well when he said, "Without music, life would be a mistake."

Physician Using Botox® Injections To Treat Headaches

EDISON Philip Hanna, M.D., an Assistant Professor at the New Jersey Neuroscience Institute at JFK Medical Center, Edison, is now providing an innovative treatment for refracheadaches, including migraine and tension headaches. He is administering injections of Botulinum toxin type A (Botox®)—used successfully as of late for everything from spasticity to cosmetic surgery--which ap-pears to be of major benefit for stopping headaches that do not respond to oral medications. The injections are generally administered every 3-4 months, often resulting in a decreased need for such oral medications with their associated side effects.

The primary purpose of the injections, which have not yet been FDA approved for the treatment of headaches, is to minimize the frequency and severity of such headaches by decreasing muscle tightness or spasms. Such muscle spasms, particularly in the neck region, appear to trigger or worsen many headaches.

"There have been substantial advances in the treatment of headaches over the past several years. Despite this, many patients end up taking many medications, which may have side effects. Botulinum toxin has the advantage of targeting the

muscle spasms directly without causing systemic side effects. In most cases patients treated can decrease the number of medications they take by mouth," said Dr. Hanna.

Dr. Hanna has extensive experience in the use of Botox® for the treatment of various conditions, including headaches. He has also been published in international medical journals, most often on the subject of certain individuals' resistance to botulinum toxin. Dr. Hanna's research, published in the journal Neurology, indicates that antibodies tend to develop if injections are given too frequently, especially in high doses. 

EDITORIAL



Summer is drawing to a close. For just about everyone, plans turn away from relaxation and turn to getting back to work. For the New Jersey Legislature, the summer's end signifies that it is time once again for each district=s representatives to converge on New Jersey's capital. Senators and Assemblyman will return and populate the halls of the long quiet Statehouse. Voting Sessions, Committee meetings, Board Lists and Bills will resume their importance after a long, hot summer. Trenton will be in full swing again.

For the full General Assembly, the first Voting Session will be held on September 23rd. While the agenda for that session has not yet been established, there are many important issues that will greet the legislature and that will keep us busy through the end of the year. And the Assembly Transportation Committee, which I chair, will hold its first meeting on September 12th.

As Chairman of this Committee, I have the responsibility to decide which bills the Committee will examine at each meeting. On September 12th the Transportation Committee will examine the laws on child booster seats. The current law requires that all children under the age of 8

years or under 80 pounds be secured in an approved child or booster seat. I helped draft that legislation. Since its implementation, there have been some calls for that law to be re-examined. The issues are varied. Is the law tough enough? Or does it go too far? Are the penalties sufficient? How does it get enforced? These are just some of the issues that will be examined.

The Legislature's not the only one going back after a long break. Students everywhere are getting ready to go back to school. And I'll be going with them. I have been asked and have agreed to serve as an Adjunct Professor in the Political Science Department of Monmouth University. I am looking forward to having the opportunity to share my Trenton experiences with eager University Students.

Class will be out for two weeks this coming November. I have been invited to travel to Taiwan at no cost to New Jersey's taxpayers. I will be part of a quasi-governmental delegation from across our nation put together by the American Council of Young Political Leaders. I look forward to meeting with my counterparts in Taiwan to exchange ideas and to learn from one another.

So as our long, quiet summer draws to a close, many of us are preparing for the burst of activity that the fall holds. I look forward to keeping you posted on my activities in Trenton, at Monmouth University, and in Taiwan.







She noted that the hospital is treating a large number of young adults and adolescents suffering from anxiety related to the attacks. "Many of our young people feel that they're not safe and that something else is going to happen. Young people just starting out are having second thoughts about traveling and in general are now feeling very anxious and vulnerable."

The days surrounding the anniversary will be especially difficult for those who lost loved ones, according to

Neary-Ludmer. "There will be memorial services for those who were lost. The media will be replaying the images of the towers falling, which will reawaken a lot of intense feelings," she said, adding, "We've been there for the last year as a resource to these individuals. We want to be available to them and to everyone during this delicate time." She noted that firemen and others who were at Ground Zero could also be affected. "The anniversary may be a time when they begin to let their guard down," she explained.

Since October of last year, Trinitas Hospital has offered various support groups for widows, for rescue personnel and for parents who lost an adult child at the World Trade Center. According to Whitlock, the

a victim of the tragedies of Sept. 11. A resident of New York City, she had always traveled the PATH from the World Trade Center to her previous parish in Kearny. Had she still been assigned there, she would have normally been boarding a train at 9 a.m. in the bottom most levels of the World Trade Center and may have been directly involved in the events of that day. With this in mind, "the events of Sept. 11 are very personal to me," said Whitlock. "For that reason, I am particularly thankful and look forward to our Sept. 15 service of thanksgiving and sharing it, not only with our congregation, but the entire City of Rahway."

On Sept. 11 itself, Zion will

also observe the one-year anniversary of the tragic events with a prayer vigil from 8:30-10:30 a.m. There will be no formal service. The Church will simply be open to all as a place of prayer and meditation. On that day, to commemorate those who lost their lives, Zion's church bells will ring at 8:46 a.m., the time when the first World Trade Center Tower was hit; at 9:03 when the second Tower was hit; 9:43 a.m., when the Pentagon was hit; at 10:05 a.m., when the first Tower collapsed; at 10:10 a.m., when United Airlines 93 Flight crashed Pennsylvania and at 10:28 a.m. when the second Tower collapsed.

"Envisioning World Peace" At Diversity Art Gallery

CLARK—Diversity Art Gallery will open its fall series of exhibitions with "Envisioning World Peace." The public is invited to attend an artists reception on Sunday, **Sept.** 8 from 1 -4 p.m.

Taking place during the anniversary of the World Trade Center tragedy, the show was conceived to express a positive vision of human capabilities to unite and live in peace and understanding. Dr. Frank Papandrea, executive director of the gallery said, "The exhibition is relevant to the mission of Diversity Art Gallery, to bring together artists of diverse styles, approaches, and cultural expressions for shared appreciation and learning."

The theme is reflected in many different ways in the content of the works by ten different artists. Curator, Dr. Christine Dolinich-Matuska expressed the importance of bringing artists together to share ideas with each other and with the community, "Global unity begins at the local level, through individuals communicating and understanding each other's differences. Art plays an important role in communication and healing. This idea is specifically addressed in some of the works in the show."

Artist Jasmine Minaya Powell presents, "A People Lost," a work composed of five stained glass panels which trace the African Middle Passage of individuals who were forced to leave their homeland. The artist will give a walk-through tour and explanation of her work at periodic intervals throughout the reception. She feels that through increasing awareness of the hardships that were endured, people will come to more deeply understand and appreciate each other. The work is exemplary in carrying out the mission of this exhibition.

The strength of art in healing is also evident in the acrylic paintings of Haesung Chung Kim, who cites Psalm 69 as the inspiration for these

works. Other strong images suggesting healing are the photographs of SM Ann Therese Kelly's installation of a labyrinth in a high school, which show students in quiet and peaceful contemplation, walking a labyrinth pathway. The artist is chair of art and music at Felician College.

Some of the artists offer a view of peace as they show individuals quietly and peacefully going about their everyday lives. Multimedia artist Victor Macarol, who just returned from exhibiting his work in Paris, contributes classic and timeless photographs of musicians deeply engrossed in their music as they perform on the streets of New York City. Documentary photographer Yolanda Avila presents an image of a woman cutting sugar cane in Ecuador. In another of her works, a young woman is glowing with the joy of a Posadas Christmas celebration.

In a unification of abstract shapes, Murphy's Lester

mixed media works combine fragmentation and reorganization of recycled materials with resultant unity in compositions that are sometimes evocative of stained glass windows. In the choice of materials, there is a reference to ecological concerhs. The artist was the curator of the spiritual art exhibitions at St. John's Church, Newark, during the eighties.

Michael Hartnett, whose meticulous brushwork creates finely detailed oil paintings, shows the human connection with the environment by juxtaposing handmade pottery with branches and leaves in natural settings to create subjects for paintings, reflecting humans living in harmony with nature. Human interaction, on the other hand, is shown in the paintings of New York artist Lisa DeLoria Weinblatt, whose images of relationships between men and women work to create humanistic awareness.

The paintings of Pennsylvania artist Salma Arastu revolve around world harmony. The artist has devoted her entire body of work to themes of world unity and harmony. Dolinich-Matuska will also include several of her own works, since her mixed media paintings and constructions often revolve around themes of world peace.

"This is a show not to be missed," according to Dolinich-Matuska. "The positive impact of the work of these artists will be felt by the viewers. These are works to be studied and contemplated." The exhibit will be open to the public from Sept. 8-23 on Sundays from 1-4 p.m; Fridays from 12-2 p.m.; and by appointment.

Services. Our blood supply is a vital resource which helps keep patients alive. Blood donations are needed every day to assure that it is there for the patients who require transfusions in order to survive. But it is the blood already on hospital shelves that truly helps in emergency situations, surgeries and trauma victims, according to NJBS. A donation made today will not be available for transfusion for two days due to the testing that must be done to assure that the blood is safe for the patient receiving the transfusion.

A pint of donated blood only lasts for 42 days and peo-

ple can safely donate every eight weeks. Every day in our nation there is a need for close to 35,000 pints of blood for transfusions.

Blood centers must collect the right amount of blood every day—enough to meet the anticipated daily needs but also have the ability to respond to unexpected emergency demands from the hospitals.





Last Sept. 11, Yates suffered second and third-degree burns over 38 percent of his body during the attack on the Pentagon. After the attack, he was treated at the Burn Unit of Washington Hospital Center. He was hospitalized until Nov. 19.

Yates still wears compression sleeves on his arms and gloves on his hands, though he is hoping to be able to have them off before the one year anniversary. Yates is back on the job; he returned to work on Feb. 19, though at first he was on a limited work schedule.

Yates is still trying to work out one question: Why me? He wonders, out of the five watching television together, "Why was I the one to survive? God has a purpose, and I have no idea what it is. He'll let me know what it is when He wants to."


Pentagon Calls Carteret Resident Pieces Honor Firefighters of 9/11

College Students And Credit Cards: What they Don't Know Can Hurt Them

AREA-Before your college freshman even settles into his or her dorm room, chances are credit card marketing teams will be on campus to sign up students for credit cards. In fact, company representatives will compete for your student's business by handling out T-shirts, coffee mugs, CDs, and other enticements. According to the New Jersey Society of Certified Public Accountants (NJSC-PA), your best defense against this marketing blitz is to set some ground rules and educate your student about the importance of using credit wisely.

Not My Child

If you think your child will resist the temptation of a credit card, think again. A student age 18 or older, with no income, can get a credit card without a parent's signatureand more than a handful do. According to Business Week, in 2000, 95 percent of college students had credit cards.

Used responsibly, credit cards can be helpful in an emergency and for establishing a credit history. But you and your child should be clear whether the card will be used for routine purchases or emergencies only and who will be responsible for paying the bill. Here are some tips that you should share with your soonto-be college freshman.

Be aware of teaser rates. Credit card companies sometimes offer low introductory

rates to attract new customers. These rates typically last for only a few months and then jump as high as 20 percent. Encourage your son or daughter to carefully compare offers from several different issuers before selecting a card.

Stick with one credit card. There is no reason your college student needs more than one card. It's easier to manage paying one bill at the end of the month, and using one credit card to pay off another is a dangerous practice that should be avoided.

Pay in full every month. It's a good idea for your student to get in the habit of paying the balance in full each month. Try to impress upon your child the merits of not charging more than he or she can pay off at the end of the month.

Pay on time. Be sure that your student knows to send the credit card payment several days in advance on the due date to allow for mailing time. Late penalties are costly and some companies will increase the interest rate after one or two payments are overdue.

Avoid cash advances. Students are often unaware that the interest rate on cash advances can be much higher than the rates charged on purchases.

Protect your credit history. Be sure your child realizes that as soon as he or she starts using a card, the payments

whether paid on time, late or not at all-become part of his or her credit history. A poor credit history can affect your son's or daughters' ability to rent an apartment, get a job, or buy a car or house. What's more-the mark stays on the cardholder's credit record even if the bill is paid later.

Don't exceed the credit limit. This helps your child avoid penalties and ensures that he or she will have credit available in the event of a true emergency. Be sure that your son or daughter realizes that a \$2,000 credit limit doesn't mean he or she can afford to carry a \$2,000 balance.

Review statements carefully. Stress the importance of immediately informing the credit card company of any discrepancies or errors on the monthly statement.

Report a lost or stolen card immediately. Encourage your son or daughter to keep a copy of his or her credit account number and the financial institution's name and customer service telephone number in a convenient place. It is important to call the credit card company immediately if the card is lost or stolen.

Protect personal information. Your college student should never give out his or her credit card number unless making a telephone, mail order or online purchase. Tell your student not to let anyone else use his or her credit card and not to charge purchases for other people.

Learning how to use credit wisely is as important a lesson as any child will learn in college. CPAs say that by addressing the matter before your child leaves for school, you may be able to help your child avoid serious credit problems in the future.

Taking On The Weighty Issue Of Backpacks

STATE—When you hear today's schoolchildren complain about homework being a pain, they may not be exaggerating. Their aching backs and necks might be caused by the heavy loads in their backpacks, according to doctors.

The issue first gained attention three years ago with an American Academy of Orthopedic Surgeons report. The Academy found that more than half of the physicians it surveyed reported seeing students whose back and shoulder pain came from carrying backpacks that were too heavy. The AAOS recommended that students carry loads no greater than 15 percent of their body weight. Also that U.S. the year, Consumer Product Safety Commission 1 reported that more than 3,400 pupils between ages of 5 and 14 were treated in hospital emergency rooms for injuries related to backpacks or book bags.

"There's a growing recognition that weighty textbooks and overstuffed backpacks may lead to real health problems for growing bodies," said Edwina M. Lee, executive director of the New Jersey School Boards Association.

School districts have responded to the concern by calling on teachers to coordinate the homework given to children, establishing longer breaks between class periods to allow students to go to their lockers to retrieve books and even by purchasing two sets of books—one for students to keep at home and one for the class-room.

Assemblyman Peter J. Barnes Jr. of Middlesex County is sponsoring a bill that would require the New Jersey State Board of Education to adopt maximum weight standards for textbooks used by children in primary and secondary schools. The legislation, A-2440, is currently in the Assembly Education Committee. California lawmakers are also addressing the issue.

A proposal, now in the California state Senate, would require school boards to distribute surveys to find creative, cost-effective measures to reduce the weight of student backpacks. Meanwhile, NJSBA's Edwina Lee stressed the role of parents in helping students to avoid injury due to overweight backpacks.

"Parents should consider what their children are carrying to school and back home," she said. "They may find that, in addition to books needed for homework, the backpacks might contain personal items, electronic gadgets and non-school items that only add weight."

Parents and students may also find helpful the following tips on safer use of backpacks, provided by the duPont Hospital for Children:

- Backpacks should have a waist belt designed to evenly distribute the weight of the contents.
- Even though some children believe it looks "cool" to allow backpacks to hang off of one shoulder and below the waist, students should use both shoulder straps and position the pack above the waistline.
- Children should not overload the backpacks.
- Children should keep good posture; hunching over while walking with a backpack increases stress on the spine.

Protecting Your Child From

Computer Overuse Injury

AREA---Whether typing a school term paper or surfing the Internet, your child may be spending many hours at the computer both at school and at home. As a result, children begin to experience the same computer-related disorders that have plagued their parents for years. However, preventing these conditions is much easier than treating them after they develop. By designing a child's computer workstation in mor ergonomically correct manner, you can help your children avoid the stresses associated with computer use and this prevent injury.

"Too often, children are using equipment that is not set up for their size putting them at postural risk," said Norma Glennon, ORT, CHT, Manager of Occupational Therapy Services, Kessler Rehabilitation Centers. "Poor posture usually leads to discomfort in the neck, shoulders, back, arms and hands."

Repetitive stress injuries (RSI) are most commonly associated with computer over use. RSI are a group of conditions, such as carpal tunnel syndrome, tendonitis and cervical radiculopathy, generally caused by placing too much stress on the muscles, tendons and nerves in a particular joint.

"When stress on a joint occurs repeatedly the body does not have time to recover and therefore becomes irritated," stated Glennon.

Resulting symptoms can include tightness, soreness, or burning in the hands, wrists, fingers, forearms and elbows; tingling, coldness and numbness in the hands; decreased strength and coordination in the hands; pain that increases at night or with sleep; and feeling a need to mas-

sage hands, wrists and arms for relief. To help reduce the possibility of your child suffering from RSI or other computer-related injuries, Kessler recommends the following:

- Proper computer placement. Position the computer monitor at or slightly below eye level, centered and approximately 18" to 24" from the eyes. "Any greater distance may contribute to poor posture if the child needs to lean forward or look up or down to read the screen," noted Glennon.
- Correct seating position. According to Glennon, proper seating may be the most critical aspect in preventing computerrelated injury. Make sure your child is seated properly with the monitor eye level, feet flat on the floor and back supported. If the chair is non-adjustable, you can improvise. Have the child sit on a firm pillow, old telephone book or a ream of paper. Or, use a telephone book or a backpack as a footrest. Also, a rolled up towel can be placed in the small of the child's back for added back support. Adjustable armrests are also recommended for additional arm support.
- Encourage good posture. Slouching forces shoulders down and forward and causes the chin to jut out and, thus, places considerable strain on the neck, back and entire upper body. "In fact, the

INTROCASO CLEANERS pressure on the back is greatest when sitting in a slouched position," said Glennon. Good posture is demonstrated by the head in a neutral position with chin tucked in; back straight; shoulders relaxed; elbows at right angles to arms; and wrists aligned with the forearm. "But, even 'perfect' posture can result in problems," warms Glennon, "If it is held to rigidly for long periods of time."

- · Teach proper typing techniques. While typing, allow the arms to move the hands around instead of resting the wrist and stretching the fingers to reach the keys. "Wrist pads should be used for rest only," stated Glennon. Strike the keyboard gently and utilize both hands to perform double-key operations such as Ctl-P. Wrists should remain neutral without bending sideways, up or down. If using a mouse, grasp it lightly without squeezing and keep it as close to the keyboard as possible to reduce awkward movements.
- Emphasize breaks every 15-20 minutes. Encourage children to stand, walk around and stretch. "Stretch breaks help reduce the muscle tension caused when the body remains in a fixed position for too long," said Glennon.
