## First-Ever Community Land Security Program Debuts In Middlesex County

MIDDLESEX **COUNTY**—Last Friday, Community Action Partnership announced that the Middlesex **County Economic Opportunities** Corporation (MCEOC) has been chosen as the first launch site for the Partnership's Community Land Security program. The announcement was made at First Baptist Church on Sewaren Avenue.

Community The Land Security program is designed to protect residents of low-income communities from terrorism.

Derrick Len Span, national president of the Community Action Partnership, said, "The education and training aspects of Community Land Security are critical because low-income people need to be on heightened alert just like the rest of the country. They are more likely to live near chemical and power plants, so they really need to be wellversed in the appropriate safety measures." Span said that to be considered for the Community

Land Security Program, a community action agency must demonstrate capacity to run the program and have other programs that it can be attached to and be able to leverage additional dollars to match the seed money provided by the partner-

The community action agency must also be able to organize volunteers from within the community; develop an evacuation plan; and show that there is an actual threat due to the community's proximity to a chemical or power plant.

In addition to creating the evacuation plan, community action agencies must present at least three anti-terrorism workshops each year. Within those guidelines, agencies may establish programs to fit their needs, Span said. Span emphasized that

Community Land Security is intended to augment the efforts of all of the agencies involved in homeland security.

He added, "Terrorism directives and warnings are currently a part of our lives. With Community Land Security, the Partnership aims to keep lowincome Americans plugged into these messages and urge them to practice homeland security techniques in their own communi-

Carroll Thomas, CEO of MCEOC, said that Middlesex was chosen in part because of MCEOC's strong ties to the community, including the cooperation of the mayors of Woodbridge, Carteret and Perth Amboy.

Thomas said that one of the benefits of MCEOC's involvement in the program is that they

will get a voice in the county and state evacuation plans. He also said that the program will help make information available, both to keep community members informed about potential threats and to keep government officials informed of suspicious activity.

Another goal is to increase the number of minorities who serve as volunteer emergency workers, Thomas said.

Thomas said that the county will be divided into five regions, and the Corporation will hold five workshops in each region.

MCEOC has a 37 year history helping residents of Middlesex County. The Corporation will have 17 locations by the end of October and runs a host of programs geared to helping people move up the ladder to self-sufficiency.

### **Perth Amboy Woman Accuses Cop**

PERTH AMBOY—A Perth Amboy woman has made allegations against a state trooper who and a story on her allegations was accused last week of having a woman perform sex acts on him in his patrol car after she sought police help.

Trooper Joseph Panick, 35, was charged Friday with official misconduct and suspended without pay as a result of the charges and an internal investigation in the matter. He surrendered to the Hunterdon County Prosecutor's Office and was later released on \$25,000 bond.

The second woman, Wendy Buckowczyk of Perth Amboy, contacted NBC News this weekend after learning of the charges against Panick, a network spokeswoman said Sunday. Buckowczyk claims Panick

harassed her after a traffic stop that occurred several years ago, aired Saturday.

County authorities declined to comment on the report, saying they had not spoken with Buckowczyk. It also was not clear if she had filed a formal complaint against Panick.

"She waits six years to report these alleged incidents," Panick's lawyer, Charles Sciarra of Newark, told the Courier News of Bridgewater for Monday's editions. "It's bizarre behavior from someone."

Panick, a 15-year veteran stationed at the Kingwood barracks, was accused of attacking the woman on Sept. 3. He was scheduled to make his next court appearance on Wednesday.

### South Amboy Receives \$1.2 Million In Federal Funds

SOUTH AMBOY—Last week, U.S. Rep. Frank Pallone, Jr. (D-NJ) announced the U.S. Department of Transportation has awarded \$1,226, 396 to the New **Transit** Jersey Corporation for the continued construction of the South Amboy Rail Station pedestrian overpass and transit plaza, which is part of the South Amboy Intermodal Transportation Initiative. This funding

announcement of more than \$1.2 million brings the total federal funding for the pedestrian overpass and transit plaza section of the project to date to \$2,966,994.

According to the Department of Transportation, the federal funds made available today will be matched by \$306,593 from the State of New Jersey through toll revenue expenditures. The total cost of the pedestrian overpass and transit plaza is estimated at \$7 million.

"The more than \$1.2 million in federal funds awarded today to South Amboy will allow the city to continue the transformation of the waterfront area. as well as continue the goal of creating a multi-modal transportation center that is both commuter and environmentally friendly," Pallone said.

### **Amtrak Train Kills Area Man**

EDISON—A man was killed late in the afternoon on Sept. 16 after he was struck by an Amtrak train at the Edison Train Station.

A witness said that the man just stepped off of the platform and onto the tracks.

Police said that the man was hit at about 4:15 p.m. They were witholding personal information pending notification of the victim's next of kin.

The train that struck the man was a Keystone Line train that originated in New York City and was en route to Harrisburg, Pa., according to an Amtrak spokesman. The passengers on that train were transferred to another train and none of the passengers were injured.

Two of the tracks at the Edison Train Station were temporarily shut down while authorities investigated the incident, causing delays for both Amtrak and NJ Transit trains.

### Schools Required To Develop Anti-Bully Policies

METUCHEN—In an effort to prevent violent behavior in New Jersey's schools, Gov. James E. McGreevey signed legislation recently at the Edgar Middle School in Metuchen that would require school districts to adopt policies prohibiting bullying.

"Our children deserve to receive a quality education in a safe environment, where they are free from threats and harassment," said McGreevey. "By requiring our schools to develop policies that prohibit bullying and encourage respect, students and parents can be assured that cruel and harmful treatmentwhether at school, on the bus, or at a school functionwill not be tolerated."

With input from parents, school employees, students, administrators and the community, the new law will require school districts to adopt policies prohibiting bullying, harassment and intimidation on school property, at school-sponsored functions, or on school buses.

While the school district will have control over the content of the policy, the new law seeks some uniformity by requiring each district to include certain com-

ponents including a statement prohibiting harassment and bullying, a definition of bullying, the consequences for committing such acts, procedures for reporting and investigating violations, prohibition of retaliation and public awareness measures. The legislation defines bullying, harassment and intimidation as any verbal, written or physical act-motivated by race, religion, gender, sexual orientation, ancestry, national origin, gender identity and mental or physical disabilities-that damages a student's property or insults, harms or instills fear in the student.

# Investing ABC: Teaching Your Kids About Stocks

AREA—More and more youngsters and teens are becoming fascinated by the stock market. Choosing stocks, tracking their performance, and making money can be exciting, challenging, and rewarding. But, as experienced investors know, the market also can be frustrating and risky, especially during volatile times.

To help kids understand the risks and rewards of the stock market, the New Jersey Society of Certified Public Accountants (NJSCPA) recommends that parents talk to their children about investing. Here is some advice to help parents get started.

### Explain The Importance Of Financial Goals

Don't start off by trying to explain options, selling short, margin calls, and other complicated concepts. Instead, begin by explaining the difference between short- and long-term financial goals and between saving and investing. To help your child understand that investing is about making money grow to meet long-term financial goals, use examples he or she will understand. For example, if your child wants to buy a new video game, he or she should focus on saving. However, if he or she hopes to buy a harley in ten years, investing in stocks or mutual funds may be more appropriate.

### Teach Them About Risks And Rewards

The safest way to make money in the stock market is to buy shares in strong companies with the potential to grow, and to hold onto them. Young investors (and older ones, too) need to understand the concept of risk versus reward—the higher the potential reward from a particular investment, the higher the risk of

#### Let Them Test The Waters

Before putting real money on the line, your child can test his or her stock selection skills and interest levels by choosing two or three stocks and following their performance. Teach your child how to find the stock price in the newspaper financial listings or online. Each day, he or she can check to see how the stocks are doing. Watch for stories on the company and share them with your child. Discuss how the story is likely to impact the stock's performance and then monitor the financial listings for changes in share price.

#### **Making The Purchase**

When minors can't ownstocks or open brokerage accounts in their own names, parents can set up custodial accounts under the Uniform Gifts to Minors Act or Uniform Transfer to Minors Act, depending on state laws. You simply complete a form with the child's name and Social Security number and the name of the custodian. You and your child should first decide which companies you want to invest in. One of the best strategies is to select stocks in kidfriendly companies, such as McDonalds, Disney and Microsoft, that are associated with products your child knows and can identify with. Buying a small number of shares without paying high commissions can be a challenge. Some companies will let you make an initial purchase directly without going through a broker, after which you can enroll in the company's dividend reinvestment plan (DROP) and buy additional shares. CPAs point out that by getting your kids interested in investing you're buying more than shares of stock. You're teaching your child financial skills he or she

can use for a lifetime.



### Retirement Goal-Setting: Factors to Consider and Available Resources

AREA—One of the most common investment goals is accumulating a nest egg for retirement. How much do you **need** to retire? The short answer is that "it depends."

Some people can live happily on about half of their pre-retirement income while others require 100% (or more) to maintain, or even enhance, their lifestyle. For many people, 70% to 80% of the amount that they earn during their working years is a realistic income replacement percentage and one that is commonly quoted in financial publications. There is no "one size fits all" answer when it comes to retirement planning.

A lot depends upon a person's goals (example: travel and hobbies) and lifestyle decisions (example: where you choose to live), as well as available resources such as an employer pension and or free or low-cost retiree health insurance from a previous employer.

Michael Stein, in his book The Prosperous Retirement. notes that there are three distinct phases of retirement: active. passive, and final. Expenses during the early years (active phase) of retirement can equal, or even exceed, those during the years before. Often, expenses decrease in later years (passive phase) but may increase again during the final phase due to medical expenses and/or longterm care costs.

The best way to make an accurate estimate of how much you'll need is to track current living costs for a month or two. Then use this information to project the amount of income that you'll need in the future. Consider expenses that will end or decrease in retirement. Common examples are:

- commuting costs and business travel
- union dues
- 401(k) plan contributions and Social Security taxes

Perhaps your mortgage will also be repaid by the time you retire and you will have launched your children successfully into adulthood.

Now consider expenses that are likely to begin or increase. Common examples are:

- travel and hobbies
- health care costs, dental expenses, Medigap health insurance premiums, and/or longterm care insurance
- gifts to children and/or grandchildren


Inflation will also increase expenses over time. Thus, a reasonable inflation rate (3% to 5%) should factored into retirement savings calculations.

Retirement analyses should be accurate enough so that people neither save a lot more money than they need to nor have to drastically lower their standard of living after retirement.

A good resource to make a round estimate of the amount of money you'll need is the Ballpark Estimate worksheet on the American Savings Education Council Web site www.asec.org. Additional planning tools from universities in the Cooperative Extension System can also be found in the "Calculating What You Need to Invest" section of the Investing For Your Future home study course at www.investing.rutgers.edu.

## McGreevey Promotes Childhood Immunization

STATE—Gov. James E. McGreevey and Gov. Sila M. Calderon of Puerto Rico recently urged all parents to have their children properly immunized.

"Immunizations are a costeffective preventative measure which save parents and children from avoidable illnesses," said McGreevey. "Gov. Calderon and I encourage all families to take advantage of the free and low-cost immunizations available in their nized," he said. "The State's communities."

"It is not that long ago that the start of a new school year cinated by age two." meant new worries for parents fearful of the spread of polio, diphtheria and a host of other childhood diseases." said Calderon. "Today, science and strong public education

programs have made these discases largely a thing of the past. But we must remain vigilant and encourage all parents to make sure their children are fully immunized."

McGreevey said children receive most of their vaccinations in the first two years of life.

"By age two, about 78 percent of New Jersey's children a rate on par with the national rate - are appropriately immugoal is to have at least 90 percent of children properly vac-

The New Jersey Department of Health and Senior Services recently initiated a statewide public awareness campaign to increase childhood immunization rates.

The campaign includes television and radio commercials, print advertisements and outreach efforts at festivals, parades and other public events.

A 24-hour-a-day, seven daya-week hotline is available (1-800-328-3838) to answer parents' questions and guide them to the nearest immunization site. The Department's hotline has both English and Spanishspeaking counselors on staff. Translators are also available for other languages. Free or low-cost vaccines, made available through the federal Vaccines for Children Program, can be obtained at participating doctors' offices and at the 13 Federally Qualified Health Centers statewide, such as CAMcare

Health Corporation Camden. Local health departments statewide also hold free or low-cost immunization clin-

In 2000, New Jersey recorded 64 cases of vaccine preventable diseases, including 58 cases of pertussis (whooping cough), four cases of mumps, one case of rubella and one case of tetanus. Nationwide. there has been as epidemic of pertussis.

The Health Department is now implementing a new childhood immunization registry to be used by all doctors and clinics statewide. This will help health care providers maintain immunization records, share records with other providers and ensure timely immunization. It will also enable the Department to collect more detailed information, including geographic and demographic data, about childhood immunization.

The Health Department is also working with the New Jersey Chapter of the American Academy of Pediatrics and the federal Centers for Disease Control and Prevention on a number of special projects to reduce barriers to timely immunization, both in public clinics and among private providers. These include streamlining administrative procedures, expanding accessible service hours for patients, and ensuring that all parents are aware vaccines are available for their children, regardless of ability to pay or insurance status.

### Armed With AEDs, Police Save Lives By Cutting Response Time

NORTH BRUNSWICK — In communities where police are equipped with automated external defibrillators (AEDs), people who have a sudden cardiac arrest have a better chance at survival, according to new research reported in the August 12 issue of Circulation, Journal of the American Heart Association.

four years, For American Heart Association has advocated that all New Jersey first responder vehicles-police, other law enforcement, fire, and emergency response- all be equipped with defibrillators. According to a survey of New Jersey police departments conducted by the American Heart Association during September and August 2001, at least 180 New Jersey police departments now have some form of defibrillator program.

According to the study published in Circulation, Journal of the American Heart Association, police in Miami-County, Florida, Dade equipped with AEDs cut response time to sudden cardiac arrest victims by almost three minutes. During the first 10 minutes after someone has a cardiac arrest, every minute saved means about a 10 percent increase in relative survival, says Robert J. Myerburg, M.D., director of the car-

diovascular division and American Heart Association chair of cardiovascular research at the University of Miami School of Medicine.

Over the last several decades, community cardiac arrest survival efforts have been concentrated on the firerescue model, in which teams train in cardiac resuscitation skills that include using AEDs. However, data from large metropolitan areas with heavy traffic congestion and from rural areas showed low overall survival rates—as low as 1-2 percent.

The results led Myerburg and his colleagues to consider expanding the use of AEDs to include police. "The theory is that police are already on the road when a call comes in, so there is a potential for faster response," he says.

The 9-1-1 emergency dispatch system in Miami-Dade was re-configured so that both police and fire/rescue were dispatched to certain medical emergency calls. Using this dual-dispatch mode, the time from the call to first responder arrival was 4.88 minutes compared to the historical response time of 7.64 minutes. With the dual-responder system, help arrived on the scene of a cardiac arrest in less than five minutes for 41 percent of calls, compared to 14 percent for the standard fire-rescue calls.

From Feb. 1, 1999 to April 30, 2001, Miami-Dade 9-1-1 dispatchers received almost 2.25 million calls. 56.321 of which were medical emergency calls that triggered the dual deployment system. Cardiac arrest was the reason for 420 of these calls with

police arriving first 56 percent of the time. Survival was 17.2 percent for 163 victims with ventricular fibrillation pulseless ventricular tachycardia (irregular heart rhythms that require an electric shock to correct). The survival rate had been only 9 percent during the one-and-a-half years just prior to establishing the police responder program.

Unfortunately, 61 percent of the victims had non-shockable rhythms, which reduced the absolute survival benefit to 1.6 percent.

Myerburg says it's likely that the high rate of nonshockable rhythms represents time lost from onset of symptoms to placement of the 9-1-1 calls. "With longer time from onset of cardiac arrest to treatment, the likelihood of survival declines," he says.

"The study demonstrates how training police and other lay responders to use AEDs can dramatically improve the outcome of sudden cardiac arrest," says Vinay Nadkarni, M.D., chairman of the American Heart Association's Committee on Emergency Cardiovascular Care. "Because sudden cardiac arrest victims have only a 10–12 minute window to be successfully resuscitated, more people must learn to recognize a cardiac emergency and call 9-1-1 immediately so an appropriate equipped first responder can treat them in time."

"Despite the existence of laws in all 50 states requiring the use of car safety seats or child restraint devices for young children, more children are still killed as passengers in car crashes than from any other type of injury." This statement, set forth in prepared testimony given before the Assembly Transportation Committee this past Thursday on behalf of the American Academy of Pediatrics, is an eye-opener. In the most recent year for which statistics are available, 539 children under 5 years of age died while riding in motor vehicles. Almost half were unrestrained and many others were restrained improperly.

Thursday September 12, 2002 was not the first time I had heard that testimony. During last year's session of the General Assembly with Assemblyman Ken LeFevre I helped write a law that toughened the standards for child restraints in cars.

The facts were clear and horrifying. Too many children were being seriously injured or killed in entirely preventable circumstances.

The legislature acted and adopted A-539 which became law as P.L. 2001, c. 244.

That law required children who were less than 8 years of age or who weighed less than 80 pounds to be restrained in an approved car seat or booster seat.

This legislation changed using a car season. New Jersey from a state option, it the law.

which lacked laws to sufficiently protect children riding in cars to the state with the toughest and most effective car seat legislation in the nation.

Since the "eight and eighty" legislation became law, there have been several measurers introduced by my colleagues to change that standard. This past Thursday all of those bills were considered by the Assembly Transportation Committee, which I chair. At the end of nearly two hours of testimony from The Academy of Pediatrics, AAA, the State Safety Council and the Safe Kids Coalition, I chose to not release any of these bills. The testimony was unanimous. New Jersey's current law is pretty good.

At some point in time down the road the Assembly Transportation Committee may revisit these bills when better language is worked out and when data becomes available on the effectiveness of the current law. Until then there will be no change in the

### A Heartfelt Thank You

Dear Editor,

On behalf of the New Jersey on Cancer Commission Research, I wish to send a heartfelt thank you to the thousands of New Jersey citizens who have purchased specialized Conquer Cancer License plates. In just four years, the sales of these license plates have generated more than \$1.3 million, all dedicated to supporting cancer research. These purchases have made a significant difference in our fight against cancer in three ways. As the second most popular specialized plate in the State, more than

27,000 New Jersey drivers demonstrate their commitment to conquering cancer on a daily basis and raise visibility on the need for research. Recently, license plate revenues have funded half of the "seed" grants awarded by the New Jersey Commission on Cancer Research to New Jersey based researchers. These talented scientists have, in turn, used three funds to leverage \$4.50 in national funds for every State dollar provided. This funding, awarded to our top research and medical facilities throughout the State, has contributed not only to New Jersey's prominence in the fight against cancer but also to strengthening our scientific infrastructure.

For years, New Jersey has consistently ranked among the ten highest states for cancer incidence and mortality. The economic costs of cancer are enormous. Recent analysis indicates that all cancer-related costs to New Jersey are estimated at over \$5 billion per annum. Needless to say, the burden from human suffering and sacrifice cannot be measured. However, it is for these reasons that the Commission is dedicated to carrying out its mandate despite its budget crises.

Again, thank you, all of you, who help the NJCCR and New Jersey cancer researchers in our efforts to eradicate cancer. I encourage your readers, especially those whose lives and families have been touched by cancer, to join with me in keeping our message of hope in the public eye. Buy a Conquer Cancer New Jersey license plate.

Bill #A2507 by John S. Wisniewski primary sponsor and John H. Adler co-sponsor reducing the time for unclaimed property to revert to the state.



### WHAT IS IN OUR GARBAGE?



### What Does it Mean to Buy Recycled?

A recycled product is one that is made from material that has been recycled.

### Why Buy Recycled Products?

Recycling is a three step process, otherwise known as the RECYCLING LOOP: Separation of recyclables from garbage, collection/sorting and processing of the recyclables, and the use of the recycled material to manufacture new products. Manufacturers will not use recycled materials in their products unless businesses and consumers purchase those products. So it is up to each and every one of us to Keep Recycling Working by Buying Recycled!!!

### Did you Know that you may Already be Purchasing Recycled Products?

Many products that you currently purchase are made from recycled materials. For example, most chipboard, such as cereal boxes, is made from a percentage of recycled materials. Glass bottles, aluminum cans, and steel cans, all contain an average 25 - 50% of recycled material according to the Environmental Defense Fund. Newspapers often contain some recycled paper content as well.

### What are Some Examples of Products that you can Purchase which are Made from Recycled Materials?

### Made from paper:

- writing paper
- greeting cards
- cardboard storage boxes
- cat litter
- notepads/ notebooks
- toilet paper, tissues, napkins

### Made from tires:

- playground cover
- door mats
- garden hoses

### Made from plastic:

- plastic trash bags
- plastic lumber
- carpet
- plastic garbage cans and compost bine
- clothing

### Others:


- aluminum cans
- steel/tin cans
- re-refined motor oil
- glass bottles and jars
- composted potting & top soil, mulch

### Where Can I Purchase Recycled Materials?

Even though they do not advertise it, most retail/grocery stores carry items made from recycled materials. The packages will often indicate what percentage of recycled materials were used. You can also visit the State's Buy Recycled website at www.recyclenj.org to learn more about where and how to buy recycled.

## Backyard Composting

Help the environment while creating a wonderful amendment for your soil!


Composting is a simple process of decomposition carried out by microorganisms and organisms commonly found in soil.

Three steps to creating your own compost are:

- 1. Add a mixture of approximately 1 part green material (grass, fruit and vegetable scraps) to 2 parts brown material (leaves, straw) in a compost bin or pile.
- 2. Add water as needed and periodically turn the pile.
- 3. Wait 6 weeks to 6 months depending on the size of the pile, the types of materials you added, and the frequency of turning the materials and your compost will be ready!

Remember, it is okay to include:

- Leaves
- Grass
- Fruit and vegetable scraps
- Coffee grounds/filters and tea bags
- Other yard waste such as chopped twigs, branches, straw hay and saw dust

### Grasscycling:

Don't bag your grass clippings. Leave them on the lawn.

### Grasscycle For a Healthier Lawn


- Short grass clippings left on your lawn act as a natural fertilizer, producing a healthier lawn that greens earlier in the spring and stays green later into the fall.
- The grass clippings shelter the tender grass roots from the sun and conserve moisture.
- Grass clippings help to create a thicker, healthier lawn that is more resistant to weeds and certain lawn diseases.
- Grasscycling does not cause thatch. Short grass clippings decompose within a few days.

### **Grasscycling Saves....**

Your Time. Experts say we spend as much as 35% of our mowing time getting rid of the clippings: emptying the mower bag, raking, filling the lawn waste bags and dragging them to the curb.

Your Money. You need to water and fertilize your lawn far less frequently, because the clippings conserve moisture and act as a natural fertilizer: they add almost two pounds of valuable nitrogen to every 1,000 square feet of lawn. You will also buy fewer lawn waste bags.

Your Town's Money. An average lawn creates about one ton of clippings each year. Municipal costs for the collection and disposal or recycling of grass clippings




run about \$100 per ton.

### 5 Tips For A Great Looking Lawn

- 1. Any lawn mower will work, but a mulching mower (or a conventional mower with a mulching attachment) will produce the best results.
- 2. Mow high. Remove only the top 1/3 of the grass blade. You may mow a little more frequently, but your overall lawn care time will decrease.
- 3. Keep your mower blade sharp. Dull blades tear the grass. This produces ragged, brown edges that invite lawn disease.
- 4. Water in the morning to a depth of one inch. Shallow watering leaves your lawn susceptible to drought stress, disease and insect problems.
- 5. Don't over-fertilize. Grasscycled lawns need fertilizer only once or twice per year.



### ATTENTION MIDDLESEX COUNTY BUSINESSES

### **RECYCLING REQUIREMENTS**

Just a reminder that all commercial establishments in the County, including but not limited to restaurants, retail, hotels, offices, warehouses, or manufacturers must have a recycling system in place. You are required, at a minimum, to recycle newspaper, glass bottles and jars, aluminum cans, steel cans, plastic milk, water, soda, and laundry bottles, corrugated cardboard, mixed paper, leaves and brush, textiles, and motor oil. Your business must have separate containers for your garbage and recyclables. You may, depending on your market and/or hauler, commingle your recyclables together.

The only exception to the requirement for separate containers is if your business has applied for and been granted a recycling exemption by your municipality. This exemption, where authorized, must be issued by your town in writing. A letter from your garbage hauler stating they will separate your recyclables from your garbage does not constitute a valid recycling exemption. Recycling exemptions are granted at the discretion of your municipality and not every town grants exemptions. Depending on your type of business, a town may refuse to grant the exemption based upon concerns with contamination of the recyclables. Contact your Municipal Recycling Coordinator (see page 16) for more information. Please note that the Division of Solid Waste Management does not encourage the granting of recycling exemptions. This exemption does not apply to residential/multifamily units.

You are probably aware that the Middlesex County Health Department is continuing their successful recycling inspection program. Inspectors visit every business establishment in every municipality as well as multifamily units to ensure their compliance with the Recycling Act and County Solid Waste Management Plan. Mixing your garbage and recyclables in one container without a proper recycling exemption means that your business is in non-compliance with the Recycling Act. Although the overall goal of the program is to educate businesses and multifamily units to recycle, a notice of violation and/or fine may be issued to repeat offenders of any recycling requirements.

If you would like to report a non-compliant commercial establishment, please call the Middlesex County Health Department at 732-745-8492.

### TIRE STORAGE and WEST NILE VIRUS

If your business regularly stores or generates tires, you should be aware of the new County storage and disposal requirements adopted in response to the West Nile Virus problem.

- If you have 5 or more used tires on your site, the tires must be stored in totally enclosed structures, closed trailers, or covered roll-off containers. The County Health Department has begun an inspection/education program to ensure that used tires are being stored and disposed of properly. You can assist in this endeavor by making your employees aware of the proper way to manage tires.
- Properly dispose/recycle your tires.
   You can contact the Division of Solid Waste Management to obtain a list of private vendors that provide tire recycling services.

### **Electronics**

Certain consumer electronics contain heavy metals and materials that are considered hazardous. These items must be properly disposed according to Hazardous Waste or Universal Waste regulations.

Televisions and computer monitors contain significant quantities of lead. Any electronic items, such as VCR's, stereos, computers, etc., can contain lead in the circuit boards as well other heavy metals like nickel, cadmium and mercury. Older clothes irons and portable electric heaters may contain mercury switches.

These items should be brought to facilities that demanufacture and remove the harmful products for proper disposal. Businesses in this area are encouraged to utilize consumer electronics demanufacturing facilities approved by the State such as:

### TIRE STORAGE AND THE WEST NILE VIRUS

## What does the proper storage and recycling of tires have to do with the West Nile Virus?

Tires stored outdoors can collect water and provide an ideal breeding site for mosquitoes, including the one species - Culex pipiens - the primary transmitter of the West Nile Virus.

### What should I do to help prevent the West Nile Virus?

Store tires indoors or in a covered container.

If you have 5 or more used tires on your property the tires must be stored in totally enclosed structures, closed trailers, or covered roll-off containers.

· Properly dispose/recycle your tires.

County residents can utilize any one of the County's four permanent Tire Recycling Program drop-off locations identified on page 9.

• Empty any objects on your property filled with standing water.

Any container or bucket that is susceptible to collecting water can also become a breeding ground for mosquitoes. These items should be removed, covered, or emptied after each rain event.

· Report illegally dumped tires.

If you see a pile of illegally dumped tires, please report it to your local municipality or to the Middlesex County Mosquito Extermination Commission at 732-549-0665.







### **Household Hazardous Waste Disposal**

It is important that you properly dispose of your household hazardous waste (HHW). This can be done in a responsible manner by utilizing our household hazardous waste days. Improper disposal of HHW can lead to environmental damage as well as possible injury to yourself and sanitation workers. The information below lists the locations and times for this Fall's collection events. Next year's (2003) tentative collection days are set for Woodbridge Public Works on Saturdays, March 15 and September 20; Middlesex County Road Dept. (North Brunswick) on Saturdays, April 19 and October 18; Middlesex County College (Edison) on Sundays, May 18 and November 16; and Old Bridge Public Works on Sunday, July 20. Please call us if you would like to be placed on our permanent mailing list. If you only have paint, paint related items or household batteries to dispose of, you may find our programs covering these items listed on page 8 to be more convenient.



### Home Collection of Household Hazardous Waste

Residents of Middlesex County who are physically incapable of bringing material to our Household Hazardous Waste disposal events may be eligible to receive a free pick-up from your home. Please contact the Division of Solid Waste Management at 732-745-4170 for details.

### Tire Recycling Drop-off Program

Middlesex County residents (no businesses) can recycle (FREE) up to eight tires with or without rims (preferably without) by bringing them to one of four locations located in the County. Be sure to see the attendant before leaving any tires. Automobile and light truck tires only on oversized tires. Tire drop-offs are closed on Sundays and holidays.

From the North: Take Route 1 South to 1-287 North (Somerville). Take the exit for Rt. 529/ Dunellen off of I-287. Merge onto Stelton Road (Rt. 529). Go straight through 3 lights. After passing a Sunoco Station on the left, turn left and stay on Stelton Road. (Do not follow Route 529). Go through one light. At the second light (end of road) turn left onto Lakeview Avenue. Almost immediately the road bears to the right. You are now on New Market Road. Just after passing a school on the left (at a triangle) turn left onto Grove St. Go through one light and follow until the road turns into South Avenue (Harry's Deli on right). Go two blocks down and turn left onto Hall St. Dunellen Public Works is at the end of Hall Street on the left. From the South: Take Route 1 North to 1-287 (Somerville). Take the exit for Rt. 529/Dunellen off of 1-287. Merge onto Stelton Road (Rt. 529). Go straight through 3 lights. After passing a Sunoco Station on the left, turn left and stay on Stelton Road. (Do not follow Route 529). Go through one light. At the second light (end of road) turn left onto Lakeview Avenue. Almost immediately the road bears to the right. You are now on New Market Road. Just after passing a school on the left (at a triangle) turn left onto Grove St. Go through one light and follow until the road turns into South Avenue (Harry's Deli on right). Go two blocks down and turn left onto Hall St. Dunellen Public Works is at the end of Hall Street on the left.

From the North: Take Rt. 18 south to Cranbury Road (Rt. 535 S), Bear right at the fork onto Dunhams Corner Rd. and continue for approx. 2.5 miles. After passing the Middlesex County correctional facility on the right, bear right onto Old Georges Rd at the sign for Maple Meade. Pass the Church Lane Plaza on the left and turn right onto Church Ln. Follow Church Lane until it ends and turn left onto Dunhams Corner Rd. The Reclamation Center will be on the left. Or Take Cranbury South River Rd. (Rt. 535 North) and turn left onto Dunhams Corner Rd. After passing the Crystal Springs Aquatic Center on the right, look for the Reclamation Center on the left. Helm (General Springs Aquatic Center on the right, look for the Reclamation Center on the left.

From the Northeast: Take Rt. 18 to Rt. 615 South (Bordentown Ave.) Main St.). Follow Main St. into Spotswood. Stay on Main St. for about 1-12 miles at which point the road splits. Bear left staying on 615 South (green street sign at fork says Manalapan Rd). Continue for just under 2 miles and turn left at the Helmetta Municipal Building. Paint site is behind Borough Hall. From the West: Take Rt. 130 to Church Lane (via Georges Rd.). Follow Church Lane east until it intersects with Dunhams Corner Rd. and turn right. Follow Dunhams Corner Rd. until it turns into Helmetta Blvd (at traffic light). Continue until Helmetta Blvd. merges with Lake Ave bearing left at the fork. From the North: Take Rt. 27 South. Once in Metuchen, go to the fourth light and turn right onto Central Ave. At the first light turn left onto Durham Ave. Go about one block and turn right onto Jersey Ave. Go to the end of the street and the Public Works office will be on the right. From the South: Take Rt. 27 North. Once in Metuchen (going under I 287), make a left at traffic light onto Bridge St. Follow until the end and make a right at the light onto New Durham Rd. Make next immediate left at a light onto John Street. Follow until the end and make a right at the stop sign onto Durham Ave. Follow for a short distance and after the large bend toward the left, make the next left onto Jersey Ave. Go to the end of the street and the Public Works office will be on the right.

Middles v Borough, 1200 Mountain Ave. (PAINT DROP-OFF SITE)

From the South and East: Take 1-287 North to Exit 9 for Highland Park and Bound Brook (or simply take River Rd.) Merge right toward Bound Brook onto River Rd. (Rt. 18) and follow to the end. Turn right onto Lincoln Blvd. Go through 2 lights and at the 3<sup>rd</sup> light turn left onto Mountain Ave. Go about 5 blocks and turn right onto Monroe Ave and continue straight to the Recycling Center and follow the one way signs. From the North and East: Take Rt. 28 (Bound Brook Rd.) West and once in Middlesex turn left onto Mountain Ave. Pass the Municipal Bldg./Police Headquarters and turn left. Continue straight to the Recycling Center and follow the one way signs.

Middlesex County College. (HOUSEHOLD HAZARDOUS WASTE

Woodbridge Ave. And Mill Road, I dison DROP-OFF SITE)

From The North/N. West: Take Rt. 287 South and take the exit for Rt. 514 West. Travel about 2 miles passing the first entrance for the college and at the light turn left onto Mill Road. Once on Mill Road travel to the first light and turn left into the College entrance. The collection area will be on the right. From The South: Take Rt. 1 North. Shortly after crossing the Raritan River take the exit for Woodbridge Ave. (514 East) Once merged onto 514 follow for approximately 2 miles. Bear right at the sign for Mill Road/Middlesex County College. Once on Mill Road, travel to the next traffic light and turn left into the College entrance. The collection will be on the right.

Middlesex County Roads Department (HOUSEHOLD HAZARDOUS Apple Orchard Lanc. North Brunswick WASTE DROP-OFF SITE)

From The North: Take Rt. 1 South to Rt. 130 South. Follow Rt. 130 for approximately 3 miles and turn left onto Apple Orchard Lane toward the Middlesex County Adult Correctional Facility. The Road Department Garage is the second building on the left, after Youth Services. From The South: Take Rt. 130 North. After entering North Brunswick, follow for approximately 1 mile and turn right onto Apple Orchard Lane toward the Adult Correctional Facility. The Road Department Garage is the second building on the left, after Youth Services.

New Branchick, 400 fersey Ave (PAINT DROP-OFF SITE)

From the North: Take the NJ Turnpike South to exit 9 or take Rt. 1 South to Rt. 18 North. Follow Rt. 18 North into New Brunswick and take the exit for Rt. 27 South/Princeton. (or simply follow Rt. 27 South) Merge onto Rt. 27 which is also called Albany St. Make sure you are in the left lane before reaching the 4<sup>th</sup> light at the train station. Continue going straight on Rt. 27 which turns into French St. Before reaching the 8<sup>th</sup> light, bear left onto Jersey Ave. (at the white clock tower). Continue going straight and follow Jersey Ave. for just under 1 mile. Turn left into the second driveway for the New Brunswick Public Works.

New Brunswick (con't.)

From the South: Take Rt. 1 North. Once in North Brunswick, get in the right lane and take the exit for New Brunswick via Jersey Ave. Follow Jersey Ave. for approximately 2.5 miles Turn right into the first driveway for the New Brunswick Public Works. OR Take Rt. 130 North. Cross over Rt. 1 onto Georges Road. At the 1<sup>st</sup> light turn left onto Hermann Rd. At the 2<sup>nd</sup> light turn left onto How Lane (right turn only). Go over the bridge and turn right at the light onto Jersey Ave. Travel just over 1 mile and turn right into the first driveway for the New Brunswick Public Works.

Old Bridge, 1 Old Bridge Plaza (HOUSEHOLD HAZARDOUS WASTE & PAINT

From The North: Follow Rt. 9 South and exit for Rt. 516 East/Matawan. Merge onto Rt. 516 East and travel approximately 1/4 mile. Municipal Center will be on the left. From The West: Take Rt. 18 South (toward East Brunswick) pass Brunswick Square Mall at right and Movie City 5 further down (on the left). Take exit for Matawan/Rt. 516 East. Follow Rt. 516 East for approx. 3 miles. After passing the interchange for Rt. 9, go approximately 1/4 mile, the Municipal Center will be on the left.

Plainshuro, Carovers Mill Road. (TIRE DROP-OFF SITE)

From Rt. 1: Take Rt. 1 South to Scudders Mill Rd./Plainsboro exit (use jug handle right after light). Cross over Rt. 1 and follow Scudders Mill Rd. through 4 lights. At the 5th light turn right onto Dey Rd. At the stop sign cross over onto Edgemere Ave. Continue straight and at the next stop sign, turn left onto Maple Ave. Follow Maple Ave. until the next traffic light and turn left onto Grovers Mill Rd. Travel about 1 mile and after the sharp bend in the road, turn left at the white and green sign that reads Plainsboro Twp. Conservation Recycling Center. Travel down the power line access road and turn right at the first driveway into the Conservation Center. From Rt. 130: Take Rt. 130 South. After passing Cranbury Station (restaurant) turn right at the next light onto Dey Rd. Travel on Dey Rd. for approximately 4.5 miles. Continue going straight through 2 traffic lights until you reach a stop sign where Dey Rd. turns into Edgemere Ave. Continue straight and at the next stop sign, turn left onto Maple Ave. Follow Maple Ave. until the next traffic light and turn left onto Grovers Mill Rd. Travel about 1 mile and after the sharp bend in the road, turn left at the white and green sign that reads Plainsboro Twp. Conservation Recycling Center. Travel down the power line access road and turn right at the first driveway into the Conservation Center.

From the North: Take Rt. 1 South to Major Road (right lane exit). McDonalds will be just beyond the exit on the right and a water tower will be on the left. Cross over Rt. 1 and follow Major Road to the end at a stop sign. Make right onto Kingston Lane. Bear right at the next light onto Monmouth Junction Road (also called Rt. 522). Turn right into the Municipal Complex and follow the road past the Municipal Bldg. (on the left) to the Recycling Center (on right). See attendant before unloading. From the South: Take Rt. 130 North. Get into the left lane after passing the Turnpike entrance sign and make a left through the center island at a sign for Deans/Dayton. You are now on Georges Rd. At the first traffic light (5 way intersection), turn left between Dayton Video and the Dayton Diner onto Monmouth Junction Rd.(Rt. 522). At the next light bear left and turn right into the Municipal Complex. Follow the road past the Municipal Bldg. (on the left) to the Recycling

Center (on right).

South Plainfield, Kenneth Ave. (PAINT DROP-OFF SITE)

From I 287: Take Rt. 287 North and take the Durham Ave./South Plainfield Exit. At the bottom of the exit ramp bear right and merge onto Durham Ave. Go through I light. Bear right at the 2<sup>nd</sup> light and proceed over the bridge (you are now on Hamilton Blvd.). Continue straight until the next light and turn right (right turn only lane) onto Belmont Ave. Travel just under a half a mile and turn right onto Kenneth Ave. (opposite the Public Works Department). Continue going straight on Kenneth Ave. past the dead end sign on the right and the James W. Conroy Memorial field on the left. The recycling center will be on the right. From Rt. 28: Take Rt. 28 to Rt. 529 South (Washington Ave). Travel about I mile. After crossing over New Market Pond, turn left onto Lakeview Ave. (which turns into New Market Ave.). Proceed through 3 lights. At the fourth light, turn right onto Hamilton Blvd. Follow Hamilton Blvd. until the 1<sup>st</sup> light and turn left onto Belmont Ave. Travel just under a half a mile and turn right onto Kenneth Ave. (opposite the Public Works Department). Continue going straight on Kenneth Ave. past the dead end sign on the right and the James W. Conroy Memorial Field on the left. The recycling center will be on the right.

Woodbridge, 225 Smith St., Keashey (PAINT, TIRE, HOUSEHOLD HAZ. WASTE DROP-OFF SITE)

From the South West: Take either N.J. Turnpike North to Exit 10 or Rt. 1 North and get onto Rt. 440 N. toward Staten Island (Rt. 287 South becomes Rt. 440 North). Take the exit for Smith St. / Industrial Ave./ Fords. Follow the signs for Smith St., bearing left toward Keasbey. Go through one light. Stay in the right lane and turn right at the sign for the Woodbridge Municipal Service Center between bridge overpasses. Go down the hill toward the river and turn right, toward the Recycling Center.

From the South East: Take Rt. 9 North to Rt. 35 North. Stay in the right lane following signs for Rt. 35 North and go around the circle. Stay right and take the Rt. 35 Victory Bridge across the river. Turn left at the first light onto Smith St. Travel less than 1 mile and stay in the left lane. Just after passing under the bridges, take the left lane U-turn. Immediately get into the right lane. Turn right at the sign for the Woodbridge Municipal Service Center between bridge overpasses. Go down the hill toward the river and turn right, toward the Recycling Center.






Think of the 3 R's when you consider what to do with those bags from the total and grocery stores!

### MIDDLESEX COUNTY IMPROVEMENT AUTHORITY'S CURBSIDE RECYCLING PROGRAM

In 1995, the Middlesex County Improvement Authority (MCIA) began its curbside recycling program in the municipality of Cranbury. Today, the MCIA program has expanded to include 17 of the 25 municipalities in Middlesex County including Cranbury, Dunellen, Helmetta, Highland Park, Jamesburg, Middlesex, Milltown, Monroe, New Brunswick, Old Bridge, Piscataway, Plainsboro, Sayreville, South Amboy, South Plainfield, South River and Spotswood.

Currently, the MCIA has a contract with Waste Management of New Jersey to service the municipalities in the program. The contractor collects the recyclables on a biweekly schedule. The materials collected include: aluminum cans, glass (bottles and jars), #1 and #2 plastic (milk, soda, water and laundry bottles), steel cans, newspaper, cardboard, mixed paper and textiles. Commingled materials (aluminum, glass, plastic and steel) are to be placed in the 20 gallon round container. Mixed paper, magazines and junk mail (no newspaper) should be placed in the 14 gallon rectangular container. Presently, cardboard is to be cut to approximately 24" X 24" wide by 24" high, bundled and tied. Newspapers should also be tied in bundles no higher than 12". Textiles are to be placed in bags provided by the MCIA.

The MCIA has a hotline for residents with questions regarding the recycling program or who have not received a pick-up by the contractor. The number is 1-800-488-6242. Please check to see if your municipality is included in the list above before calling.

The following communities operate their own curbside recycling programs consistent with the County-wide Recycling Plan: Carteret, East Brunswick, Edison, Metuchen, North Brunswick, Perth Amboy, South Brunswick and Woodbridge. If you are a resident of one of the nine communities listed above and have any questions on your recycling program, please contact your Municipal Recycling Coordinator. See page 16 for phone numbers.

### ATTENTION TEACHEDS

The Middlesex County Division of Solid Waste Management has a number of educational resources for teachers who wish to obtain instructional information about solid waste and recycling. An "Environmental Resources Guide" which lists activity guides, videos, books, and field trips that are available through the Division or other agencies were mailed to all schools last year. If you did not receive a copy, call the Division at 732-745-4170 to obtain one.

The Division also sponsors assembly programs for elementary schools during the spring and fall terms. Professional performers are hired to present shows about recycling and solid waste. To inform schools about the shows, letters are sent to the principals of each school. This is usually done in September, and again in December. Shows are booked on a first come, first served basis.

The MCIA has an assembly show featuring their recycling robot, "MC Blue". These shows are available for all age groups. Contact the MCIA at 609-409-5033 if you are interested in booking an MC Blue show.

In addition, Middlesex County provides \$10,000.00 towards Environmental Awareness Contest grants. Grants of up to \$1000.00 each are awarded to qualified schools and environmental groups. The contest is held each year and requires the submission of an application due in June. Grant award notifications are mailed in early fall. Examples of projects awarded grants in previous years included composting demonstrations, litter pickup programs, and environmental resource libraries. If you are interested in this program for the 2003-2004 school year, call the Division at 732-745-4170 to be placed on the mailing list for the application, which is sent out in the Spring.



### FREE USE OF EDUCATIONAL VIDEOS



If your school or civic group is looking for a video on recycling or waste management, the Division of Solid Waste Management has a FREE lending library. ### LITTER

### What is litter?

Litter is waste that is discarded improperly either intentionally or unintentionally.

### Why do people litter?

- They feel no sense of ownership or respect for the property
- They think someone else will clean up after them
- Litter has already accumulated there
- · They do not realize the consequences of their actions or the potential harm the litter can cause

### I only litter occasionally, what harm can that cause?

Litter can cause injury to animals (including marine life) and humans, pollution, fires, and costs hundreds of thousands of your tax dollars to clean up.

### What are the most commonly littered items?

According to the Clean Ocean Action's survey in 1999, cigarette butts topped the list of the most common item found during their beach cleanup. Other items on their list of the "dirty dozen" included plastic bags, caps, lids, straws and plastic beverage bottles along with glass and metal beverage bottles.

### More about cigarette butts....

Many smokers who don't properly dispose of their cigarette butts may not realize the negative impact that the butts have on the environment. Cigarette filters are made of cellulose acetate, a plastic that can take 5-10 years to degrade in the natural environment. According to Kathleen Register from Clean Virginia Waterways, filters are designed to trap carcinogenic chemicals and these chemicals can leach out of a used cigarette filter which is a potential biohazard to aquatic life. ### What can I do?

<u>First and foremost, DON'T LITTER.</u> The best way to get others to change their bad habits is to provide a good example.

Don't just complain about litter, TAKE ACTION! Organize a litter cleanup in your neighborhood. Many towns and the County have adopt-a-road or adopt-a-spot programs. If not, most would be willing to provide supplies for a neighborhood cleanup.

If you see your friends or family littering, let them know their actions are inappropriate. Many people litter because of ignorance and are willing to change their behavior once they realize the environmental damage that litter can cause.

Remember: Every "litter" bit hurts!

### Middlesex County Clean Communities Program

The Middlesex County Clean Communities Program takes a three pronged approach to solving the litter problem: Cleanups, Education, and Enforcement. The State previously provided funding to all counties and most municipalities to implement a program to reduce the amount of litter in their community. The funding for these grants was through a tax on fifteen potential litter-generating items. Unfortunately, the tax sunset, therefore towns and counties will no longer receive these grants. Efforts


are underway to reinstate the State Clean Communities Program. Middlesex County has used its grant to fund an Adopt-A-Road program and a highly successful program for the cleanup of roads, parks and other public places by a work detail consisting of low-risk inmates from the Adult Corrections Center. These programs are continuing in 2002 and we hope to continue them into the future.

### Middlesex County Adopt-a-Road Program

This Program is a way for organizations and citizens around the County to assist the County in achieving our mutual goals of safe, attractive and litter-free roadways. Additionally, the Program serves to raise the level of public awareness concerning the amount of roadside trash. Groups choose a one-mile stretch of a County Road to clean. They must then perform two cleanups of both sides of this stretch of road during the grant year. Each cleanup should be no less than 2 months apart. After the second cleanup, the group will have a sign placed along the roadway they adopted identifying who they are and illustrating their commitment to the community. 

# Distinguished Lecturer Series At William Paterson University

AREA—FBI and CIA interaction in the face of terrorism, as well as changes in America in such areas as politics and businesses, will be under discussion this year as William Paterson University presents the 23rd season of its Distinguished Lecturer Series beginning in October on the campus in Wayne.

Anna Deavere Smith, a playwright, actor and professor, opens the series on Oct. 11. Stansfield Turner, former director of the Central Intelligence Agency, and Louis Freeh, former director of the Federal Bureau of Investigation, discuss homeland security on Nov. 22. Terrorism and threats to America are topics of discussion for Senator Fred Thompson on Feb. 14. Financial services visionary Christos M. Cotsakos, chairman of the board and CEO of E\*TRADE Group. Inc., will present a lecture on changing the rules of engagement on March 28. The Capitol Steps, a comedy team made up of Capitol Hill staffers, will perform on May 2.

Tickets for the series are maintained at an affordable level as the result of the generosity of the program's partners. Deavere Smith, whose presentation is titled, "Snapshots: Glimpses of America in Change," has made a name for herself in the theater through her performance pieces, which explore issues of race, community and character. In 1996, she was awarded a prestigious MacArthur "genius" Fellowship, for "creating a new brand of theater-a blend of theatrical art, social commentary, journalism and intimate reverie." She has also appeared on television in "The West Wing," and this season is starring in the new CBS series, "Presidio Med." She is the founder of the Institute on the Arts and Civic Dialogue based at Harvard. Deavere Smith is a tenured professor in the Tish School of the Arts at New York University, with an affiliation at the NYU School of Law.

"Homeland Security Interagency Cooperation" is the topic of a speech to be presented by Stansfield Turner and Louis

Freeh. Turner, as ClA director, and Freeh, as director of the FBI, have many years of experience between them heading huge agencies charged with protecting America and her citizens. After a long career in the Navy, where he earned the rank of admiral, Turner was named to the ClA by President Jimmy Carter. He has taught at Yale University, West Point, and in 1991, he joined the faculty of the Graduate School of Public Affairs at the University of Maryland at College Park. President Bill Clinton appointed Freeh director of the FBI. A lawyer, he began his career in law enforcement as an FBI special agent. Freeh held various positions in the New York City U.S. Attorneys Office including Deputy United States Attorney; he was also appointed to the U.S. District Court for the Southern District in New York. Freeh now serves as senior vice chairman for administration at MBNA Corporation, the largest independent credit card lender in the world, overseeing legal affairs and is responsible for personnel, facilities, security and transportation functions.

Senator Fred Tennessee Thompson, who retires from the U.S. Senate in January 2003, discusses "Threats to America Present and Future - Terrorism and Beyond" in one of his first appearances. post-Senate Thompson has had an eclectic career that includes politics, the law, and acting. He is a member the powerful Senate Committee on Finance, which has jurisdiction on taxes and the Social Security and Medicare programs. He is also a member of the Senate Select Committee on Intelligence and the National Security Working Group, which observes and monitors executive branch negotiations with foreign governments. He is a member of Council on Foreign the Relations, which promotes improved understanding of international affairs.

Christos M. Cotsakos is chairman of the board and CEO for E\*TRADE Group, Inc., a global leader in online personal financial services. A William Paterson graduated alumnus-he 1973-Cotsakos is considered

one of the visionaries and architects of e-commerce, e-finance and digital financial media. His unique leadership style has transformed a struggling online trading company to a full-service financial service industry leader. His book, "It's Your Money, The E\*TRADE Step-by-Step Guide on Online Investing," was a national bestseller with all the proceeds going to charity. Cotsakos will speak about "Changing the Rules of Engagement."

The Capitol Steps, a comedy group that pokes fun at politicians in Washington and beyond, concludes the series on May 2. Consisting of Capitol Hill staffers, the group has built a reputation for irreverent humor based on the proposition that if entertainers could become politicians, then politicians could become entertainers. They have produced 18 comedy albums, have been featured on three PBS specials and can be heard on National Public Radio.

## Senate Candidate Arrested At News Studio

EDISON—As his supporters shouted, "Let Ted In," Green Party U.S. Senate Candidate Ted Glick was arrested on Sept. 5 as he tried to enter the News 12 studio where his Democratic and Republican opponents were to debate.

room of the News 12 Studio in Edison, where he was charged by police with criminal trespass. The chanting quickly turned to "shame on you."

He was subsequently released without bail for a court appearance Oct. 1.

Glick had been seeking per-

debate between Democratic Senator Robert Torricelli and Republican Douglas Forrester so that he might counter their remarks to the press afterward.

Glick and his supporters had gone to the debate site to protest his exclusion from participating in the debate as a candidate.

"The least they can do is to let me in to reply to their remarks," he told his supporters who had gathered with banners, placards and even a pounding drum outside the studio in the Raritan Center industrial complex.

"They refuse to let me in and I refuse to leave until they can do that," Glick said.

He was arrested at 7:59 p.m., one minute before the debate, sponsored by News 12 and the Star-Ledger was scheduled to begin. The public was excluded from the debate which also called for the candidates to be questioned by News 12 and Star-Ledger reporters.

Glick and about 75 shouting, chanting and singing supporters had congregated outside the studio at 6 p.m. along with similar groups from the Torricelli and Forrester camps.

Glick had gained entry to the anteroom with his wife. Jane Califf, and State Green Party Chairman and Congressional Candidate Joseph Fortunato along with campaign staffer Blyden Potts.

They argued for some 30 minutes with News 12 representatives and police before Glick was arrested and placed in handcuffs. The others were not arrested.

The debate was the first of slated several for the Democratic and Republican senatorial candidates. Glick has so far met with no success in seeking to participate.

Glick said he had been told by a News 12 executive that he didn't have enough recognition to be admitted to the debate. His challenge to Torricelli and Forrester to debate at another venue has met with no reply.

"It's a Catch 22," Glick said earlier. "They won't give us a chance to let people know about us and then they say that because people don't know us they won't give us a chance.
