Ferry Service To Start Feb. 4

SOUTH **AMBOY** Workers are busy preparing for the Feb. 4 opening date of the Seastreak USA ferry service. which will take passengers from South Amboy to Manhattan.

The ferry service plans to run four round trips per day to East 34th Street in New York. According to information posted on Seastreak's website. www.seastreak.com, a round trip would cost \$33 during peak hours and \$25 during offpeak hours and on weekends.

Free parking will be available at the South Amboy terminal lot, which will accommodate around 300 cars.

Eric Nielsen, project manager for Joseph Jingoli & Son Inc., the firm that heads the South Amboy Redevelopment Corp. (Devcor) said. "It will be similar to Penn Station in New York."

Recently, workers were widening the ramp to the one lane bridge over Main Street that will provide access to the ferry access terminal. Other workers were installing fencing around the old Reliant Energy cogeneration plant, which will be converted into offices.

Devcor has also recently broken ground on a new road to

the ferry terminal. They are rebuilding Main Street near the terminal as a four-lane road. The state Department of Transportation has provided \$3.5 million for this project.

There are also plans to build a \$6.5 million bridge to connect Main Street with the ferry terminal and the train station by year's end.

Businesses that will be part of the terminal, including a coffee shop, restaurant and dry cleaners, are still more than a VCAT AWAY.

In the next 18-24 months, the city plans to improve the marina near the terminal. The area now has rusted structures and debris from the area's history as a coal transfer point. It was also the site of the explo-

sion of a barge loaded with military ordinance in 1950, which cut the northern waterfront off from the rest of the city for years.

According to Joseph Jingoli, Jr., CEO of Jingoli and Son, Devcor is negotiating with a company to put a large power plant on 10 acres in the northern waterfront area.

In the southern waterfront area. Baker Cos. is constructing the 185-home Lighthouse Bay development. The development is expected to expand the tax base by nearly \$200 million and provide homes for hundreds of new residents who will spend money at city businesses, according to Kenneth Wilson, vice president at Baker





Bill Toughening Hate Crimes Act Becomes Law

STATE Acting almost 19 months after the U.S. Supreme Court declared New Jersey's hate crimes law unconstitutional, the Acting Governor recently signed into law Assembly Deputy Majority Leader Neil M. Cohen's legislation to revise the law so convictions remain future enforceable.

Cohen's bill (A-2702) will give jurors the expressed power to convict individuals of bias crimes and impose the harsher penalties authorized for hate-crime offenses. Previously, the state's hate crimes law made judges responsible for deciding at the time of sentencing whether harsher bias crime penalties should apply in the event the judge decided a defendant was motivated by bias.

"At a time when acts of intolerance are on the rise against Jews and Muslims, it is in New Jersey's best interest to have a hate crime law that will stand up in court," said Cohen (D-Union). "We need to send the message to individuals who trade in hate that their **crimes** will be met with tough and certain penalties."

Cohen's bill (A-2702) will require a prosecutor to charge a

defendant in a hate crimes case with "purpose to intimidate" so that a jury could hear evidence during a trial on that charge. Cohen was also co-sponsor of the original hate crimes act and sponsored an amendment that included crimes based on gender and disabilities.

The new law addresses issues that arose in the wake of a June 2000 decision when the Supreme Court ruled 5-4 that the Constitution requires juries aot judges to determine when a hate crime was committed before imposing tougher penalties.

The law also will require prosecutors to prove beyond a reasonable doubt to a jury that a person committed a hate crime by seeking to intimidate a victim because of his or her race, color, religion, gender, handicap, sexual orientation or ethnicity.

"There needs to be harsher sentences for hate crimes, but the state can't circumvent the Constitution to do so," said Cohen. "Charging a hate crime offender with intimidation and proving it in court will put these kinds of criminals behind bars where they belong."

Menendez Announces Over \$2 Million In Healthcare And Education Funding

STATE—Rep. Bob Menendez (D-NJ) has announced that over \$2 million in funding was passed in the Labor, Health and Human Services and Education Fiscal Year 2002 Appropriations Bill for the 13th Congressional District.

"The passage of this bill recognizes the continued importance of education, healthcare, and job training, not only in our district, or in the state of New Jersey, but across the nation," said Menendez. "In these trying economic times, I will continue to work to ensure that opportunities are available for every member of our community."

The following funding for the 13th District was included in the Labor-HHS-Education FY 2002 Appropriations Bill:

• \$600,000 for the American Airlines Travel Agency for a multi-state education demonstration project, which integrates a comprehensive travel/hospitality industry

Local Offices For Sept. 11 Victims Set To Open

STATE Two Sept. 11 Victim Compensation Fund offices opened Friday, Jan. 18 in New Jersey for the families of the victims of the terrorist attacks on our country.

The offices one in Jersey City, the other in Edison will be open six days a week and each will be staffed by at least six people. Senators Robert Toricelli and Jon Corzine said that the decision to open two offices in New Jersey to help families apply for money through the Victim Com-

pensation Fund recognizes the deep impact that the attack on our country has had in the state.

Special Master in charge of the Victim Compensation Fund, decided to place two offices in New Jersey at the urging of Senators Torricelli Corzine. Both Senators thanked Special Master Feinberg for following through on his promise to open offices in New Jersey.

Torricelli and Corzine in-

tend to pursue changes in the law regarding the Victim Compensation Fund due to their concerns regarding the Kenneth Feinberg, the limits set for non-economic damages for pain and suffering. They will also be working to eliminate the provision that deducts life insurance payments and pensions from the eventual compensation award.

> Regulations and applications for the Sept. 11 Victims Fund will be available in both New Jersey offices. Family members will also be able to review the status of applications at the offices and staff members will be available to answer questions.

ChildWatch **Helps Make Communities Safe**

AREA—Thankfully, Spring Lake's six-year-old Anna Cardelfe is home and safe after being kidnapped. This is a good time to stress the message that our neighborhoods are safer when people who live and work in an area are aware of what is going on around them.

To support this effort, PSE&G, and all electric and gas utilities in New Jersey have created ChildWatch programs. If a child is lost, injured or feels threatened, they can approach one of over 5,300 PSE&G vehicles or enter a PSE&G customer service center for assistance. The vehicles are equipped with two-way radios so PSE&G can contact the police. PSE&G employees will wait outside of the vehicle with the child until the police arrive.

PSE&G worked with public safety officials and police departments throughout the state to help create safer neighborhoods for our children. ChildWatch is designed to support and supplement the police department and other community safety programs- not to replace them.

Identifiable markings on PSE&G vehicles include orange and yellow stripes, the PSE&G logo, which includes a large "energy burst," and every PSE&G vehicle carries a ChildWatch sticker on both sides.

PSE&G urges parents to occasionally ask children if they have noticed any PSE&G vehicles in the neighborhood and to let them know that the PSE&G employees who work in those trucks and vans can help them. PSE&G has a commitment to helping to make our communities safe.







New Tax Law Offers Benefits But Also Requires More Decisions This Year

AREA Many taxpayers got an advance installment on their 2001 tax savings in the fall last year without filling out a single form. Now, as April 15 approaches, things get a little more complicated.

Some of the biggest benefits of the tax law, rate reductions, won't take any extra mental effort when you file your federal tax return. You read the tax tables, just as always. To take advantage of some of the

other benefits, however, you'll need to plan and make decisions, according to the tax experts at the New Jersey Society of Certified Public Accountants (NJSCPA).

Rebates and Rate Reductions

The rebate checks many people received, \$300 per tax-payer for many people, were an advance credit, based on the taxpayer's 2000 federal tax return. The money represents the tax reduction people will

get as the result of the creation of a new 10-percent tax rate. If you didn't receive a rebate check, or if it wasn't for the full \$300 per taxpayer allowed, you may be entitled to some additional credit on the return you file this year. You will be able to claim the credit on Form 1040,

Line 47; Form 1040A, Line 30, or Form 1040EZ, Line 7, according to the Internal Revenue Service

lf you can be claimed as a dependent, you cannot claim the Rate Reduction Credit, but you may get the benefit of the new 10-percent tax rate by using the Tax Computation Worksheet for Certain Dependents. Rate reductions, one half of 1% in the top four tax brackets, will be reflected in the tax computation tables, according to the IRS.

Child Care and Education

The child tax credit increases to \$600 per child this year, and it is no longer required that there be three children for this prevision to apply. College and professional school students will also benefit from a change in the rules that makes

withdrawals for higher education expenses from state-run "Section 529 Plans" tax-free. Interest on student loans will be deductible until the loan is paid off. In the past, interest on student loans was only deductible for five years.

Retirement Savings

People who are planning for retirement will be able to save significantly more money in tax-sheltered IRA and 401(k)accounts, including 405(b) and SIPs. The limits for IRA accounts will go up by \$1,000 annually for the next three years. The limit on 401(k)-type plans will go up \$500 this year and then \$1,000 a year through 2006. Additionally, people 50 or older will be able to make "catchup" contributions. Taxpayers who are serious about planning

for retirement will have a great opportunity to increase their savings while reducing their current tax bill.

Other Tax Law Changes


The new tax law introduced more than 85 major provisions in areas ranging from making Holocaust restitution payments tax free, to increasing the estate tax benefits for people who donate land for conservation purposes (the Qualified Conservation Easement Exclusion).

Employers Urged To Double-Check Wage Reports

AREA—Social Security urges employers to file error-free wage reports. The wage reports filed by employers in January (and February, or through March for electronic filers) reflect the amount of wages paid to employees and the taxes withheld for Social Security, federal, state and Medicare during the previous years. According to Dennis Mass, Social Security manager, Elizabeth, Social Security

receives 240 million wage reports a year.

Small employers are more likely to have errors in their wage reports. Large employers are required to make wage reports by magnetic media or electronic filing, but businesses with fewer than 250 wage reports have the option of filing by either magnetic media of paper, a more error-prone process. "Errors in filing these reports can, be cost-

ly, both to workers who rely on the earnings information for accurate retirement, survivors, disability, and Medicare hospital insurance benefits and for employers, said Mass. "Correct reporting saves time and money for the employer and for the government."

Social Security investigates over 200,000 wage reporting errors annually. The Internal Revenue Service (IRS) can assess penalties for the employer if discrepancies in wage reports are not corrected. Correct reporting insures that employees have the proper wage amounts credited to their Social These Security records. amounts are used to calculate the Social Security benefits payable to the worker and his or her family if the worker dies, becomes disabled, or retirees and determine the worker's eligibility for Medicare coverage. Employers should use the W-2 form for the proper year. For example, a W-2 form for 2000 cannot be used to report 2001 wages.

Be sure to file Copy A of the W-2 form with Social Security. When a copy other than "A" is filed, it is more costly to process and may result in errors.

Frequent errors also include a misplaced digit in the Social Security number, failure to reflect a name change in the newly married or divorced and incorrect or misspelled names, particularly in the case of Hispanic and Asian surnames.

POPCORN "In The Bedroom"

Where Real-life Nightmares Reside

Each film is unconsciously and innately connected to a slew of words that eagerly beckons to describe it. It's like a movie review just waiting to be written, not unlike what Rodin said about sculpture. He assured that the images he carved already resided within the stone, and that all he did was chip away the excess. With cinema, these staples of the film critic's vocabulary flit in and out of your mind as you watch. And in the case of "In The Bedroom," a disturbing domestic drama featuring great performances by Sissy Spacek, Tom Wilkinson and Marisa Tomei, the preeminent term that comes to mind is wrenching.

Fast on its descriptive heels are heart-rending, thoughtful, searing, violent and alarming. But though in combination they describe what is essentially an estimable piece of art, it's doubtful even "The Thinker" could handle seeing director Todd Field's contemporary tragedy more than once a decade.

This is tough stuff. And being uncompromisingly realistic, its purposely uncertain conclusions are hardly intellectually consoling enough to mitigate the psychological devastation preceding them. Optimally, you see "In The Bedroom," note the artistic achievement, discuss with kindred souls what it all might mean (preferably over some comforting cuisine), and then just hope you're better for the experi-

Probably the most frightening thing affirmed by Robert Festinger's screenplay is how utterly uncivilized even the most cultured among us can act. Being painfully reminded that we aren't quite as safe in our society as we would like to think, that real life means having no net to catch us, can put you on edge. And it's precisely this scathing edge that "In The Bedroom" mercilessly rides on the way to telling its

But though it begins quite casually and seemingly without any

special poignancy at a backyard barbecue tossed by Dr. and Mrs. Matt Fowler, you may not at first notice director Field's economy of exposition. Hence you won't catch "In The Bedroom's" New Englanders (small-town Maine, to be exact) engaging in small talk. And when you think you have, you're wrong. Listen care-

They're always saying something, either about their feelings or as a presentiment of what is to betide them. And though Mr. Field spares us the washing ashore of dead albatrosses and other such obvious portents, what we're supposed to get out of the social gathering is that the Fowlers' only offspring, Frank (Nick Stahl), is keeping company with Natalie Strout (Marisa Tomei), an older woman. Uh, that's a separated and not yet divorced older woman with two small children, to be more specific. Which has Mrs. Fowler, magnificently portrayed by Sissy Spacek, more worried than most.

You see, Frank is scheduled to begin college in the Fall. And Mom fears that the smitten lad, previously obsessed with architecture, may stay behind to play house instead of designing them. But while the affable yet con-

fused young man unconvincingly confides that it's just a summer thing, Dad's angst is later aroused when the honor student does offhandedly talk about skipping academia and becoming a lobster man, like his granddad was; maybe the call of the sea skips a generation, he opines. Oh, and one more thing you ought to know. Natalie's husband (William Mapother) is a jealous ne'er-do-well. Thus, as Mr. Shakespeare was once heard proclaiming, the stage is set.

And things do not bode well in Maine. But it would be a misprision on the critic's part to tell much more. So suffice it to note that the reference to Shakespeare is not mere chance. For while "In The Bedroom" doesn't quite meet the classical Greek definition of tragedy, odds are that if the Bard came across this tale, he'd more or less recognize some of his less happier contemplations. You know: a dash of "MacBeth," a smidgen of "Hamlet." Just enough to make things really sad and miserable. Which was probably a lot more fun in Shakespeare's time, when bad things happened more readily, and simply knowing that what has scourged the actors has not befallen you was in and of itself

an entertaining relief.

However, in today's more sanitized social climate, that's a given. Our tragedies have become sublimated to our greater goal of becoming one with the big yellow smiley face. Women of leisure no longer have the vapors. Melancholia as a sign of breeding is out. If we find our surroundings unhappy, chances are we are crazy, depressed, low on some very expensive pharmaceutical, or, at the very best, a stick in the mud. And thus when a film astutely, artistically and infallibly reminds us that unspeakable danger lurks in the simplest elements around us, it is a harsh awakening.

But is it entertaining? Does such dire tutelage necessarily fit the definition of entertainment? That, and whether or not the starcrossed characters of "In The Bedroom" might have avoided their anguish, are speculations better left to that compulsory apres film dinner.

"In The Bedroom," rated R, is a Miramax Films release directed by Todd Field and stars Sissy Spacek, Tom Wilkinson and Marisa Tomei. Running time: 130 minutes

New Special Ed. Law Will **Provide Taxpayer Relief**

AREA The NJ School Boards Association recently praised former Acting Governor Donald T. DiFrancesco for signing legislation that will boost the state's commitment to special education — without requiring additional state spending during fiscal year 2002-03

The bill ultimately will provide state funds to local school districts for all special education costs in excess of \$40,000 per pupil These costs usually reflect the placement of students in facilities outside the district as a result of state and/or federal requirements or court orders An NJSBA report issued in 2000 showed that the cost of out-of-district special education placements can exceed \$100,000 per pupil and, in some cases, is above \$200,000 per student. The vast majority of those costs are borne by local property tax payers.

"The special education funding

act will be remembered as one of the major legacies of the DiFrancesco administration, which never lost sight of the education and health needs of New Jersey's children." said Edwina M. Lee. NJSBA executive director. "The legislation's sponsors, Senators Robert Martin and Richard Bagger, are to be commended for their determination to provide funds that school districts need to meet their state and federal responsibilities for children with special needs"

The additional state aid will also relieve local property taxpayers who shoulder a disproportionate share of state and federally required special education costs, according to NJSBA.

Under the legislation, the new state funding will be phased in over a three-year period, beginning with the 2003-04 budget year. The state will provide the increased funding according to

the following schedule:

2003-04- 60° of any costs in excess of \$40,000 per pupil and up to \$60,000

2004-05 70% of any costs in excess of \$60,000 and up to \$80,000

2005-06-80% of any costs in excess of \$80,000

2006-07 and afterward—100% of special education costs in excess of \$40,000

Because of the state's pending fiscal crisis, the bill was lan-

guishing in the Legislature and was likely to die on the vine when the legislative term ended on Jan 8 To salvage the bill, NJSBA asked the sponsors to amend it, so there would be no immediate fiscal impact With the amendment, the legislation gained final approval.

Up to now, school boards had limited opportunity for financial relief from extraordinary special education costs. They could appeal to the state when special

education costs for a student exceeded \$40,000. But not all districts were granted relief and. often, amounts granted represented only partial reimbursement. For example, the state Dept. of Education reports that it received 2,276 applications for additional funds in 2000-01 to assist with extraordinary special education costs. The applications totaled \$33.1 million. Of that amount, only \$14.9 million was provided to local school districts.

Association Grants \$25,000 For Potential Principals

STATE — Thanks to a \$25,000 grant from the Prudential Foundation, the leadership development program. Principals in Training, will be extending to provide effective training to prepare potential school leaders for New Jersey's public schools "The Prudential Foundation's investment reflects its commitment to school leadership development," said Jo Ann Bartoletti. Executive Director of the New Principals Jersey Supervisors Association. "The quality of our schools depends upon the effectiveness of school principals, and the Principals in Training program seeks to address the increasing shortage of principals by taking potential candidates through a year long training program focusing on skills essential for success in the principalship. We are grateful to the Prudential Foundation for

providing us with the resources to facilitate this project."

The grant will provide potential school leaders with the opportunity to participate in monthly sessions led by highly successful, currently practicing school principals. The program focuses on direct instruction, case studies and job simulated experiences. Training sessions feature topics such as the climate and culture of schools, leadership styles, curriculum planning, supervision and evaluation of staff and school law.

Now in its third year, Principals in Training reaches out to individuals who have completed or are near the end of graduate work or who have been identified as potential school leaders. The program helps to prepare participants to become effective school principals by focusing not only on academic theory, but also on essential

skills and practical knowledge Candidates come from across the state and represent rural. urban and suburban schools. The program requires that the superintendent of each candidate support participation.

Studies have shown that the United States is in the midst of a severe shortage of school leadership. The Principals in Training program was developed in response to the growing shortage of quality applicants for school leadership positions. It provides a clinical practicum for future principals.

The New Jersey Principals and Supervisors Association is the state's largest organization of school admin- ... istrators, serving over 6,000 school leaders. NJPSA focuses on school quality and the professional leadership needs of all school administrators and supervisors and is dedicated to assign school leaders in their efforts to improve teaching and learn-



We Can And Will Learn To Fight This New War

Dear Editor,

The last time the U.S. military went into action, in Kosovo, it relied on jetfighter aircraft and rockets or smart bombs and electronic technology. The time before that, in Desert Storm, it relied on those same weapons, plus troops using big, fast tanks, trucks and jeeps. Earlier, in Vietnam, it relied on jet bombers and fighters, tanks, electronics, sea power and ground troops equipped with modern weapons. In Korea, it was air, sea and ground firepower, plus maneuver. But this time, in Afghanistan, it will be a different kind of war, one reminiscent of Iwo Jima and Okinawa, battles that were fought more than a halfcentury ago.

The enemy in Afghanistan will be in caves, rocky defiles, and trenches, armed with riffes, grenades, some mortars, a few radios, and perhaps some radar. Every enemy soldier, apparently will be ready to die in defense of the country. That is as it was on Iwo Jima and Okinawa. The difference is the size of Afghanistan, almost as big as Texas, as opposed to Iwo Jima (5 miles long, a cou-

ple of miles wide) or Okinawa (about 25 miles long, generally 2 or 3 miles wide). The Japanese had caves, defiles, and trenches. They had some artillery, mortars, some radio communication and infantry prepared to die.

Before the invasions, the U.S. Navy and the Army Air Force and Navy fighters pounded the islands with shells, bombs and napalm, in two of the most powerful attacks ever. They devastated almost everything above ground. But they hardly took out any enemy soldiers. What worked on Iwo Jima and Okinawa was infantry. The Marines and Army took fearful casualties, as many as if not more than the numbers of enemy on the islands. They took almost no prisoners, not by choice but because the enemy simply would not surrender. The critical weapons were rifles, grenades, to some extent mortars, satchel charges and most of all, flame throwers. To overcome the Japanese, the Americans had to work their way up to the entrances of the caves, then send flames into the openings. That either burned the Japanese or, by sucking out all the oxygen, suffocated them.

The terrorists in Afghanistan have at their disposal what amounts to a nearly unstoppable weapon, in some ways the ultimate weapon. It is a man willing to give up his life for his cause. In World War II, the U.S. Navy took its most severe losses not at Pearl Harbor, the Battle of Midway, or the Battle of the Atlantic, but in the Philippines, Iwo Jima and Okinawa. What sank more American ships and killed more sailors than any other weapons was the Kamikaze. There was no machine then, and no computer now, that can respond as fast or as accurately as the human eye and brain. Kamikaze pilots are relatively easy to train and difficult to stop.

What we most need is to improve and extend our surveillance. After Pearl Harbor, there were congressional investigations to attempt to find out what happened and why our intelligence was caught so badly off-guard. How on earth in 1941 could American intelligence, at a time of great tension between Japan and the Untied States, lose the Japanese fleet? Scapegoats were found. Intelligence was improved and extended, and by 1944 was

the best in the world. That can be done again.

We have spent more than half a century providing our military with the best weapons, the most advanced weapons, the technologically superior weapons. They deterred the Soviet Union, as they were designed to do. Now it is not the Soviet Union we are fighting, and few of those high-tech weapons will make much difference in Afghanistan. What we will rely on is the human component, most of all intelligence and especially our ground forces. As is almost always the case in war, it will come down to the poor bloody infantry. But as the Marines and Army showed at Iwo Jima and Okinawa, American soldiers will be there and will prevail.

One final thought: After the unconditional surrender (which we also are demanding of the Taliban), we turned Japan from a feudal, criminal society into a flourishing democracy. Perhaps we could do something similar in Afghanistan. At least we could try.

K-Mart Declares Bankruptcy

AVENEL—The blue light it a difficult environment for seems to be fading at K-Mart. The beleaguered retailer filed lysts. for Chapter 11 bankruptcy protection on January 22.

While the recession has made the environment for retailers tough in general, this is just the latest in a string of bad news for K-Mart.

Not only has the company announced that weak December sales would cause it to miss analysts' earnings estimates for the fiscal year ended Jan. 30, but credit rating agen-Moody's Investors Service and Standard & Poor's have each downgraded their credit ratings on the discount retailer.

The company has 20 retail stores in New Jersey, including one on St. Georges Avenue, Avenel.

Competition from more nimble discount retailers like Wal-Mart and Target has made K-Mart to compete in, say ana-

Chief among K-Mart's problems, say industry watchers, are its ability to compete on price, which stems from an inefficient supply-chain infrastructure.

While discounter Wal-Mart is renowned for its "just-intime" inventory system that allows the company to restock products as necessary and keep its costs low, K-Mart lacks this efficiency.

"They decided to take Walmart on by way of trying to create what they call price parity," says Kurt Barnard, president of Barnard's Retail Trend Report, Montclair. "That is impossible. You can't do that with Wal-Mart. That's like having the state Luxembourg declare war on the United States."
