Perth Amboy Awarded Quarter Million For Washington Street Reconstruction

The funding will cover the cost of a complete milling and resurfacing of Washington Street from New Brunswick Avenue to High Street. Washington Street is a welltraveled transportation vein, which is sorely in need of rehabilitation due to the high volume of cars that create daily wear and tear on the surfaces. The project is timely because Middlesex County will be opening a brand new Vocational-Technical High School at the corner of Washington and High this year and the city will also be breaking ground on the Landings at Harborside, which will have a bearing on the transportation route as well.

The city expects to send the project out to bid in January and break ground some time during the spring. Perth Amboy has been extremely aggressive in seeking funds to pay for muchneeded street repairs. Over the last five years, more than 100 streets have been resurfaced, many of them through state funding. The Transportation Trust Fund continues to be a major source through state funding. Wilentz Critical After Car Crash

WOODBRIDGE One of New Jersey's most powerful Democratic insiders, attorney Warren Wilentz, was in critical condition last week after being involved in a serious auto accident in Edison.

Police said the accident occurred as Wilentz was driving at about 9:30 a.m. Wednesday, Dec. 4 from his home in North Edison to his law firm on Woodbridge Center Drive in Woodbridge.

Lt. John Dauber said Wilentz's car collided with an auto driven by Pushpa Patel, 52, of Edison at the intersection of Plainfield Road and Stephenville Parkway.

Patel did not suffer any injuries and refused medical treatment at the scene. Dauber said.

Wilentz, 78, was the 1966 Democratic candidate for U.S. Senate and a senior partner at Wilentz, Goldman and Spitzer.

Wilentz has been viewed as one of Gov. James E. McGreevey's mentors.

McGreevey and State Supreme Court Justice Barry Albin, a former partner in the Wilentz firm, both visited Wilentz at Robert Wood Johnson University Hospital in New Brunswick.

Friends said they were told Wilentz might have suffered a severe neck injury or possible damage Warren Wilentz to his spinal

cord.



David father, His Wilentz, was the state Attorney General who prosecuted Bruno Hauptmann during the famous Lindbergh baby kidnapping trial, and his brother, Robert Wilentz, was Chief Justice of the New Jersey Supreme Court.

Wilentz is the only living unsuccessful Democratic nomince for U.S. Senator in New Jersey, where Republicans have lost the last ten races. He lost the 1966 Senate race to

Republican Sen. Clifford Case by a 60° o -37° o margin.

Wilentz. Goldman Spitzer, established in 1919 by David T. Wilentz, is one of New Jersey's largest and best known law firms, with 151 attorneys.

A former prosecutor and county attorney in Middlesex County, Wilentz has been very active in community and civic causes. Past chairman of the Woodbridge Metropolitan Chamber of Commerce and a trustee of the Association of Criminal Defense Lawyers of New Jersey, he has served as a trustee and chairman of the Middlesex County Legal Services Corporation and as president of the Middlesex County Bar Association.

Wilentz is also chairman of the Woodbridge Economic Development Association and former general counsel to the New Jersey Highway Authority, which operates the Garden State Parkway.

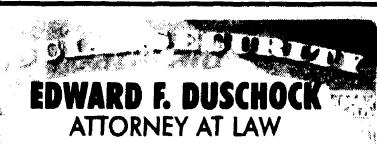

May Not Be Exclusive Enough For Some

sweet-souled, Although high-minded and absorbing, "The Emperor's Club" makes the mistake of retelling a favorite old tale without performing enough of a twist to satisfy those who demand permutation with each variation. The story of that great educator in your life, it also makes the mistake of being warm, fuzzy and nostalgic. So much so, in fact, that while you watch you can practically hear the world's cynics having a field day.

The nerve of them. And here you are having such a nice time remembering how influential and inspiring Mr. Stamelman proved; how amazing it was that Mr. Green managed to bring the whole world into the classroom. They saw something in you. And the only way you could ever pay them back for their special indulgence was to make something of yourself.

Of course you can just imagine your brother-in-law Marty, in that cynical tone of

his, pointing out how director Michael Hoffman's story about a dedicated teacher can hardly stand up to "Goodbye Mr. Chips" (1939), the granddaddy of the genre, as well as a halfdozen or so other films. He'd then proceed to name every movie that ever contained an educational theme, whether he had seen it or not, pointing out that there just isn't enough room on this Earth for another one: "Why you wanna see the same thing again, when it's been done better?"

Oh well. That's your brother-in-law Marty. He made a fortune in the tire retread business. And ever since he's had the conceited notion that it gives him the right to pontificate at will on all subjects. Geez. And to think, before you turned him on to it, he thought "Goodbye Mr. Chips" was about the death of a snack food Yet here's the rub. mogul. Though you hate to admit it, technically he's right. Others have done this many times, and indeed better. But then again, in another way he's wrong. In dismissing "The Emperor's Club" as just anoth-

er, er, retread, he's really missing the point. And probably missing out. But then, that's Marty

Think about it. How many of your most cherished films are truly representative of great cinema? Yet you welcome them into the den over and over again. Because they speak to you. And while "The Emperor's Club" won't necessarily become one of your favorites, its heart is in the right place. What it lacks in novelty and nuance, it practically makes up for in compassion. Hence viewers who don't believe the wheel must be reinvented with each new film will find Kevin Kline endearing | as William Hundert, teacher and Western defender **Civilization** at St. Benedict's Academy.

When first we meet the scholar, it is on the eve of a benefit being thrown in his honor. We giggle as the retired professor fumbles with the newfangled phone in his room. Kline sets the tone.

This is a good man...a man steeped in tradition. And the occasion gives him cause to reflect. A flashback follows. It is twenty-five

years ago and a middle-aged William Hundert, already firmly ensconced as an institution within an institution, strolls the campus. It is the first day of school. Kids point him out. The excitement of new beginnings permeates the air. In the classroom, welcoming his new students, the esteemed teacher quotes the Greek philosopher Heraclitus, stating: " A man's character is his fate." And then he apprises them of how the school motto, "The end depends upon the beginning," complements the sage's affirmation.

In any other year, no one would think to challenge St. Benedict's statement of mission or question its self-proclaimed role as a molder of tomorrow's men. But then this is the year that Sedgewick Bell, portrayed with effective lordliness and contempt by Emile Hirsch, comes to school. The son of a U.S. senator, the obnoxious snot is determined to be difficult, to prove that he will not be poked, prodded or shaped beyond his will.

Of course your brother-inlaw is snickering at this juncture, satisfied as a Cheshire cat when Professor Hundert predictably adopts the insolent creep as his special project, because he "sees something" in him. And for a while, the plot does take the typical Hollywood route prescribed for devoted teachers and impertinent students. At least for the moment, Mr. Hundert wins Sedgewick's interest by involving him in the school's annual Julius Caesar competition. If your knowledge of the Roman Empire places you among the top three scholars, you get to go to the finals, a festive and well-attended tradition at St. Benedict's. Win that and you are crowned Caesar. Your picture goes up on the wall, laurels and all.

The big night comes, and lo and behold, your brother-inlaw Marty is forced to wipe the smirk from his face. Surprise! Things don't go quite the way he thought. Neil Tolkin's nicely etched script, based on Ethan Canin's short story, "The Palace Thief," throws its first of several, albeit mild, curves. The story then reverts back to the present and leads up to yet another unexpected turn of events. And it's here that finally the nagging question that's been in the back of your mind since the get-go---'Why didn't they just do a remake of

"Goodbye Mr. Chips?" -- is As it turns out, answered. "The Emperor's Club" does have its own little slant to proffer, and this includes a major life lesson, not for the students at St. Benedict's, but for Mr. Hundert. And while to tell any more of the plot would give too much away, suffice it to note that in addressing some age old questions about the human character, director Hoffman separates the world into two groups. Perhaps you'll recognize them. They're in the news all the time. The two probably go back as far as the Sumerians...maybe all the way to Cain and Abel. These days they call themselves parties. But regardless of what you

call them, there are folks like Mr. Hundert, and then there are people like Marty. Mr. Hundert is an idealist, maybe to a fault. Marty would call himself a pragmatist. Mr. Hundert feels man can be redeemed, even when he does his darnedest to prove otherwise. Marty believes you can only trust man to do what he feels is in his own best interests. The Professor Hunderts of the world believe man can rise above the rule of the jungle. That he must. That his survival as a species ultimately depends on it. Marty has resigned himself to the notion that it's a dog-eat-dog world. Hence if you can outsmart your fellow man, you'd be a fool not to do so. There are several other, perhaps less significant, differences between the Professor Hunderts and the Martys. For example, I think the Martys still eat veal. But that about covers it. Granted, as your brother-in-law Marty was so quick to point out, time and again we've been taught the humanistic lessons filmmaker Hoffman's professor of classics imparts. Yet surprisingly enough, the world still seems to be in quite a fix. Thus the thinking here is that a refresher course courtesy of "The Emperor's Club" couldn't hurt. And it sure beats joining Marty's gang.

Heart Devices, Transplants Have Similar Costs; What Will We Pay?

Mechanical heart pumps. known as left-ventricular assist devices (LVADs), can significantly improve survival and the quality of life of patients with end-stage CHF-a weakening of the heart muscle that keeps the heart from pumping enough blood for the body's needs.

The new finding poses public policy questions about paying for expensive new devices in light of rising concerns about healthcare costs. "The LVAD has clearly been shown to save lives," Oz says. "But are we, as a society, willing to pay the costs to save these lives?"

The investigators analyzed the medical and cost records of 68 patients who received LVADs during a study called REMATCH. The Randomized Evaluation of Mechanical

Assistance for the Treatment of Congestive Heart Failure was a multicenter trial sponsored by the National Institutes of Health and Thoratec Corporation. They divided the LVAD patients into four groups, or quartiles, according to the cost each person incurred while hospitalized. They didn't include the cost of the LVAD, which is about \$65,000.

The average cost for LVAD treatment was \$196,699.

The major contributors to hospital costs were time spent in the intensive care unit or a regular hospital bed (39 percent), pharmacy expenses (15 percent), supplies (14 percent) and diagnostic procedures (11 percent).

The time LVAD or organ transplant patients in the middle two quartiles spent in the hospital ranged from 16-55 days. These patients represent the type of person likely to receive an LVAD in the future, say the researchers. Several factors predicted how long patients would stay in the hospital. For example, patients who developed general or device-related infections tended to have longer hospital stays. The infection rate can be reduced, Oz says, which would lower the procedure's

"The major implication of this study is that we have a lifesaving technology that is going to be expensive to deliver," he says. "The question we have to address as a society is whether it is worth the expense to put these devices in patients. Our study tells us that these costs are comparable to heart transplantation and liver transplantation (\$205,000 and \$250,000), which society is already willing to pay for.

"The costs, from my perspective, are less than many would have expected at such an early stage with a device like this," Oz says. "Improving management of these critically ill patients will substantially reduce the costs of this evolving technology."

Modern medicine is indeed Our lives are a miracle. longer, infant mortality is down, severed limbs can be reattached, and organs are routinely transplanted. Cures for what were incurable diseases are being found. New technology allows doctors to **see** inside the human body with a clarity and accuracy not even imagined in science fiction. It is truly a wonderful time to be alive if you need medical care - if you can get it.

Of course, if you need emergency care you can walk into any emergency room in this state and get care. But will you be able to get that care if there are no doctors there to give the care you need?

According to one trade organization, New Jersey is one of twelve states experiencing a medical crisis because of sky-rocketing malpractice premiums. And what, you may ask, does medical malpractice insurance have to do with finding that the doctor is "out," permanently? In New Jersey doctors are required to have medical malpractice insurance in order to offer their professional services in their office or in a hospital. Sky-rocketing insurance premiums mean that some doctors may not be able to afford to continue to practice medicine in New Jersey. If they can't practice here, it is possible that you may one day go to a physician's office only to find that the doctor is "out" permanently.

The New Jersey Legislature is at work trying to make sure that the doctor stays "in" To be introduced soon is the "Patient's First" plan. It offers both short and long-term solutions to this crisis and will ensure the availability and quality of health care in New Jersey.

The comprehensive tenpoint plan would provide greater oversight of medical malpractice insurers, restructure insurance underwriting policies, give judges more leeway in reviewing exorbitant jury awards and reduce situations where a conflict of interest could arise involving directors of insurance companies.

The Plan would also provide a searchable database information containing regarding malpractice awards or settlements against a This database physician. would be available to all citizens to research a physician over the Internet or by telephone. It would enable citizens to take a pro active role in deciding on a doctor in whom they can trust. The Plan would also require expert witnesses in malpractice litigation have identical credentials as the defending doctor and be actively practicing or teaching in the same field as the doctor.

This Plan is the result of several hearings on the medical malpractice issue that have been held by members of the New Jersey General Assembly. This Omnibus legislation will be introduced shortly and will be the subject of further hearings before legislative committees.

The increasing cost of medical malpractice insurance is a problem. To be sure, the problem is not solely created by litigation. Insurance companies have made bad decisions in their investments. They too, like all of us, have been adversely affected by the fall in values in the equities markets. But regardless of the cause, skyrocketing premiums threaten to reduce the number of doctors practicing in New Jersey. That reduction will be even more severe in certain specialties. If we want to make sure health care consumers have the widest possible choice, we need to act now.

Our medical technology is unsurpassed and even miraculous. But that technology is useless unless people can go to a doctor to access it. Without reform now, new Jersey's health care consumers will be like the swimmer just out of reach of the life saving rope. So close, yet so far. Through the Patients First plan, we can make sure that the doctor is "in" for everyone that needs one.

Controlling the Demands of Holiday Giving

As we get ever closer to the time of holiday gifts, parents across the nation are slowly being worn down with requests for toys their children "just can't live without." And while every parent would like to make their child's dreams come true, unfortunately many parents often misinterpret those requests for expensive toys as being what their children really want.

But stop for a minute and think of your own fondest memories of your childhood and the holidays. Are your most positive memories really of some expensive toy, or are they of the laughter and love and warmth of the holidays and the holiday spirit?

Children won't say no to the toys, but what they really want is the feeling of closeness they get on the special day when the family is together. Turning down the buying fervor of the holiday season doesn't mean just saying "no" to your children's toy requests, but instead channeling energies into activities that will produce warm, lasting memories.

The bombardment of ads directed toward influencing whining that you've been hearing for that "special" toy are the result. And while you can just give in and say yes to every-

- * Create a realistic budget base it upon what you can afford to buy in cash. When you're reaching for the credit card, you really can't afford the gift.

- * Avoid toy store temptations - Unless shopping for another child, stay out of toy stores when shopping with your child. When you do enter a toy department, firmly state "we're focusing on giving to another person today," and make it stick. If your child begins manipulating or whining about the toys he or she wants, make it clear you'll leave the store if it continues, and then follow?up on your promise the first time it begins again. Don't make a scene or give a lecture, just leave and tell your child he or she made the choice.
- * Let your child to develop a wish list - But make clear that you may or may not stick with it because part of the joy in giving is selecting something you think is special. By fourth grade, children should also be encouraged to write down the price of each item on the list. If they don't know, they're old enough to research it. This will help them to begin connecting a price tag with their wants.
- * Make helping the less fortunate a holiday tradition -Local social agencies can offer many ways for your family to volunteer or provide help to those in need. Such activities can be a great source of positive holiday feelings.

It can be tempting to try and be a super parent during the holiday season. Don't. It's better to downsize everyone's activities. Encourage your children to help with decorating and cooking. Schedule enough rest time for everyone. Help your family see the value of the holidays is in more than just buying gifts.
